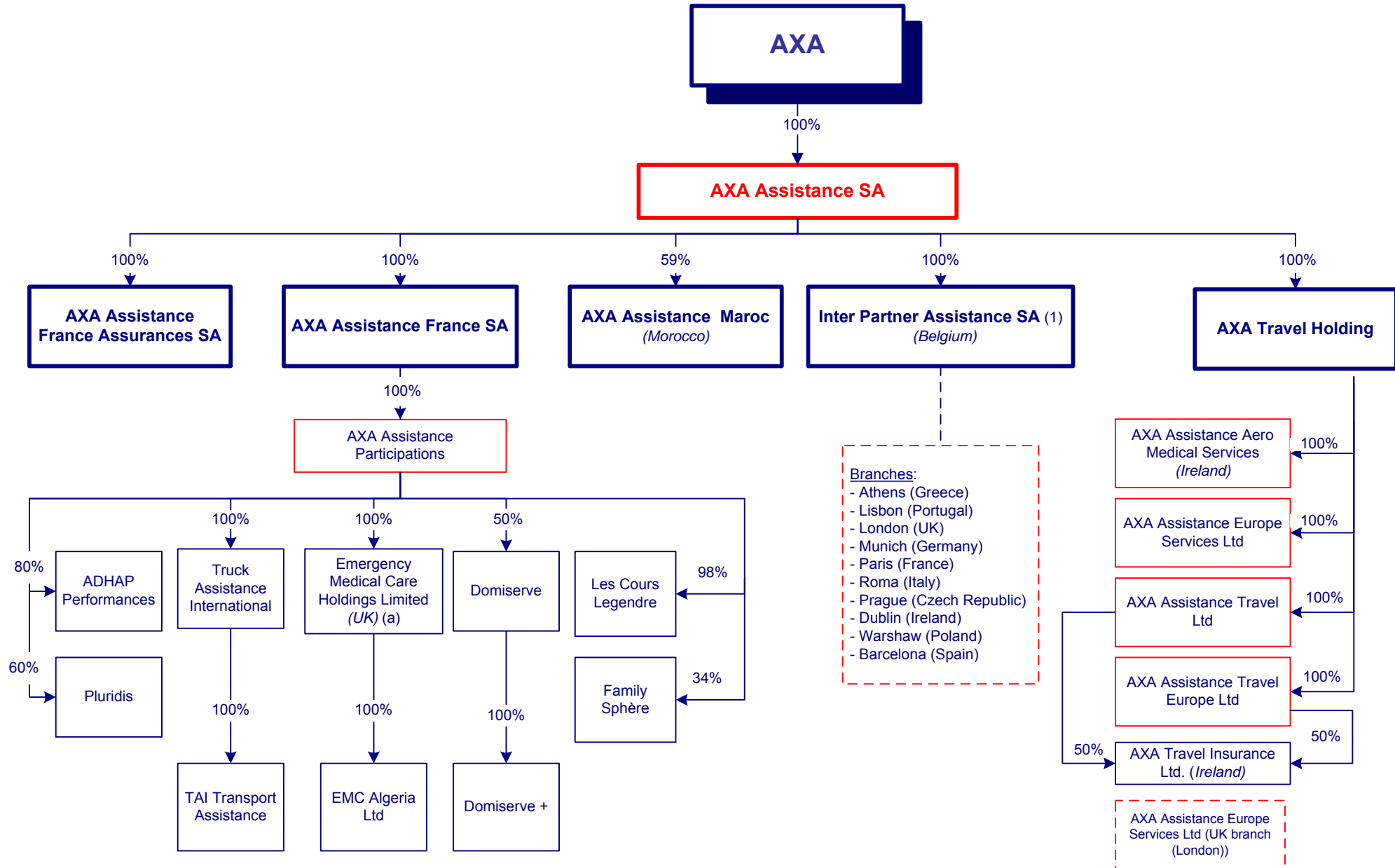

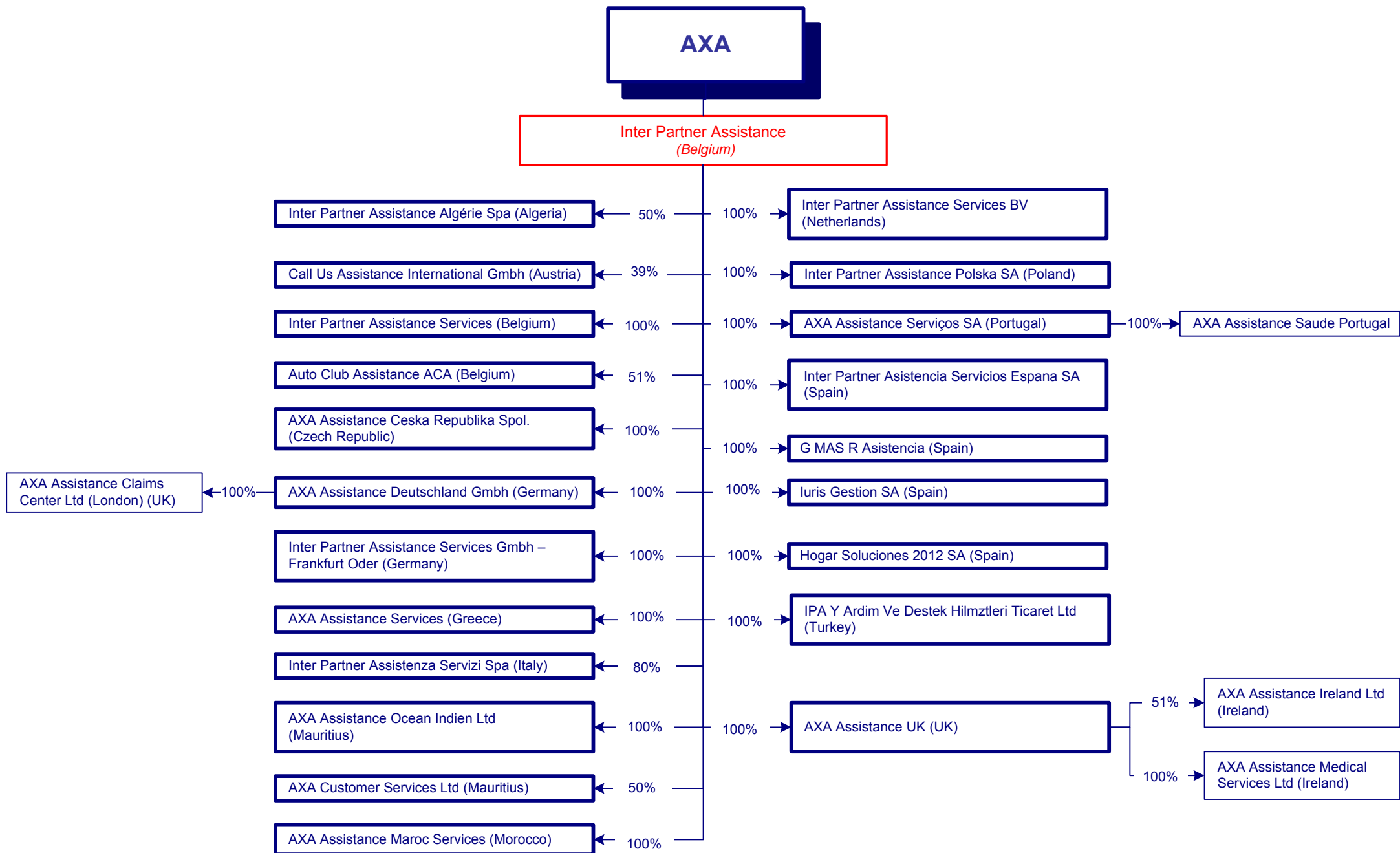

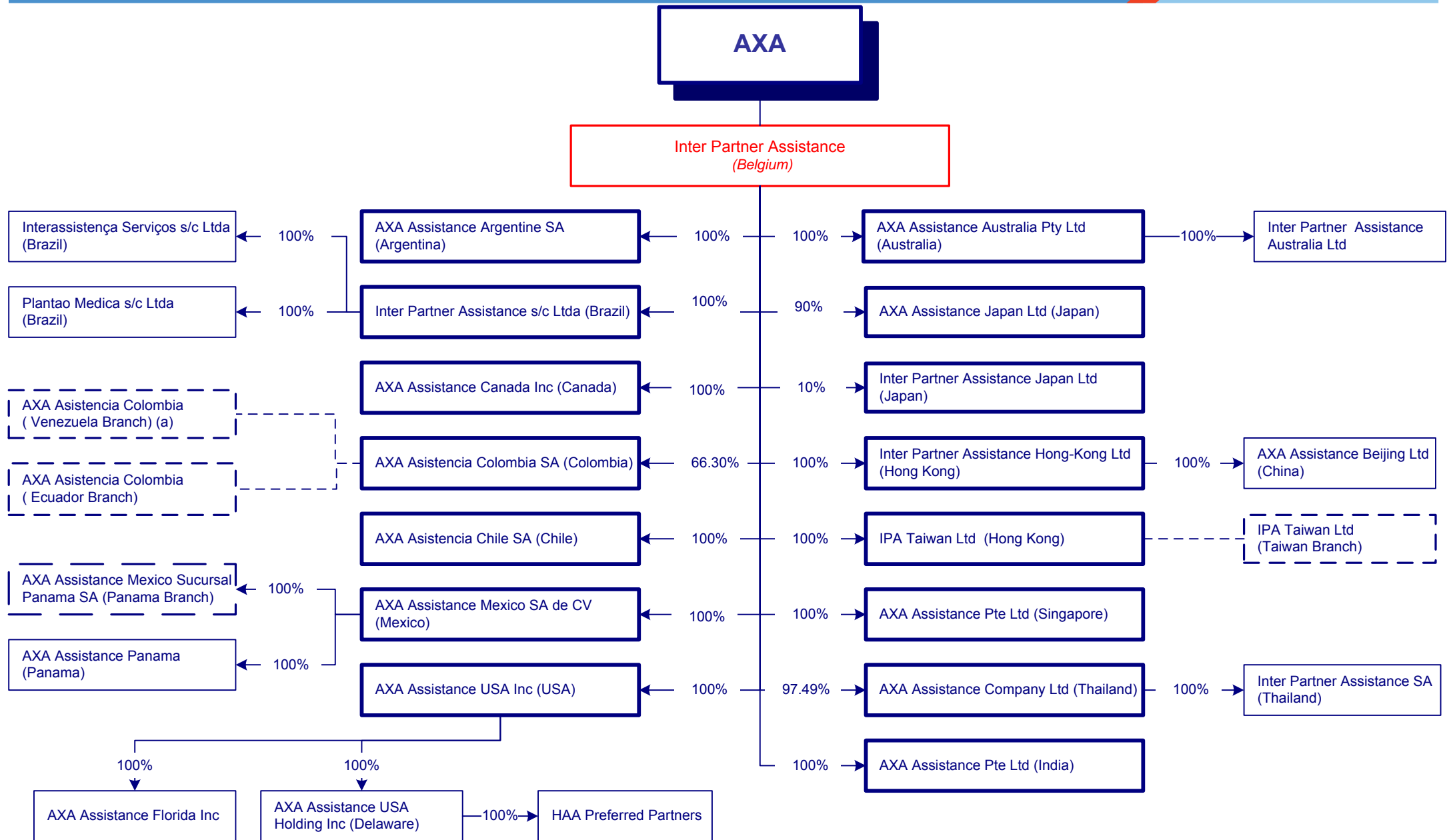

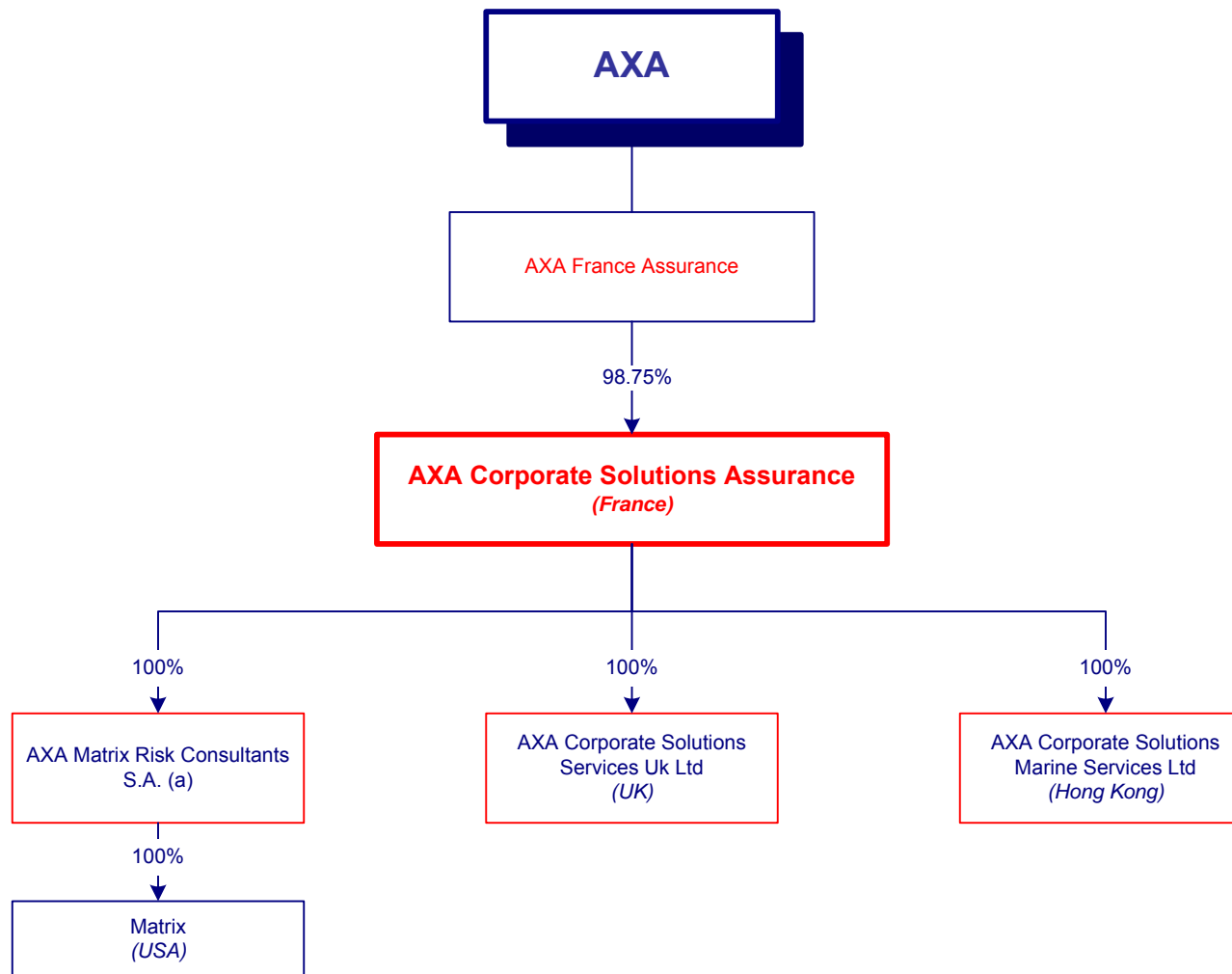

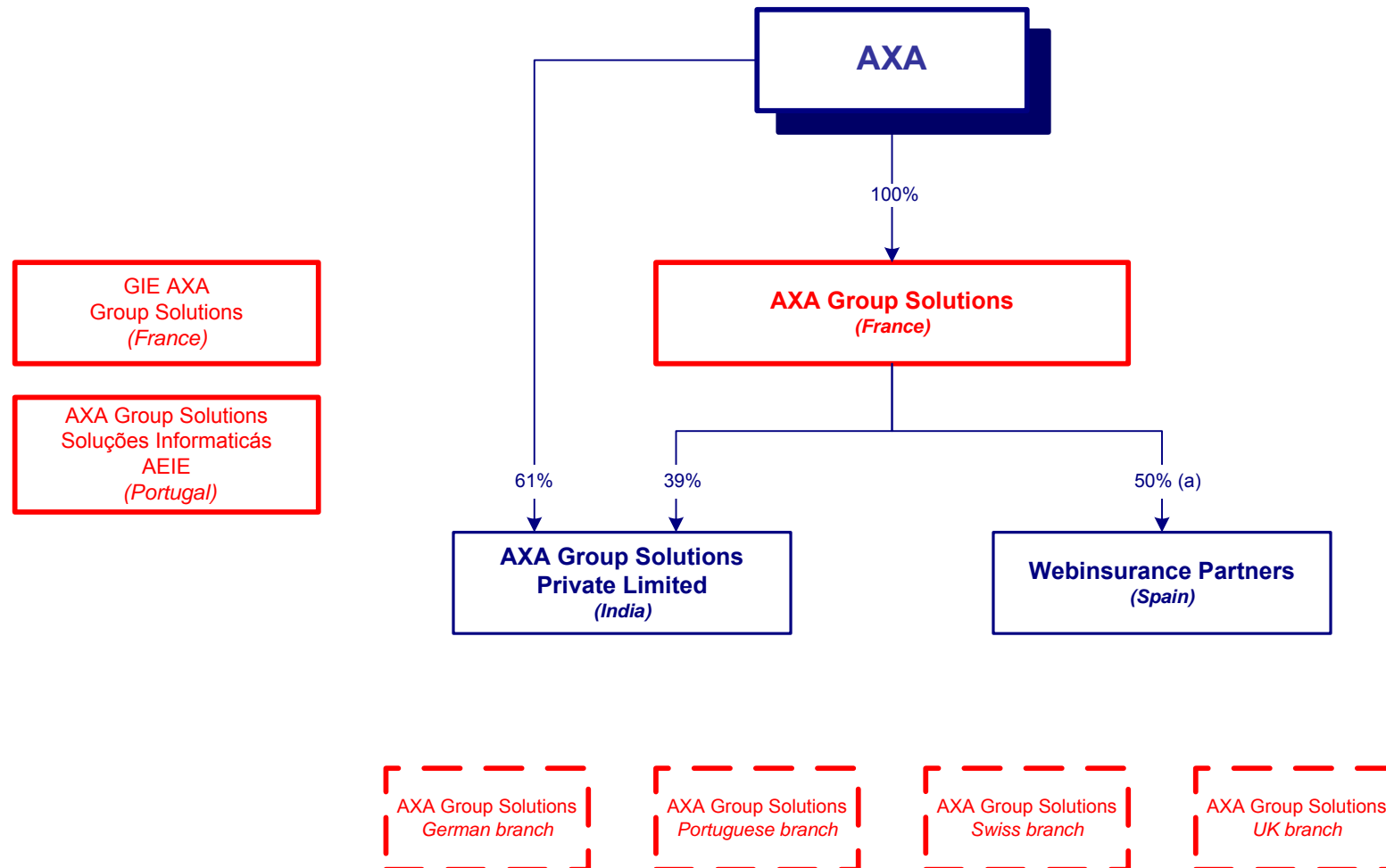

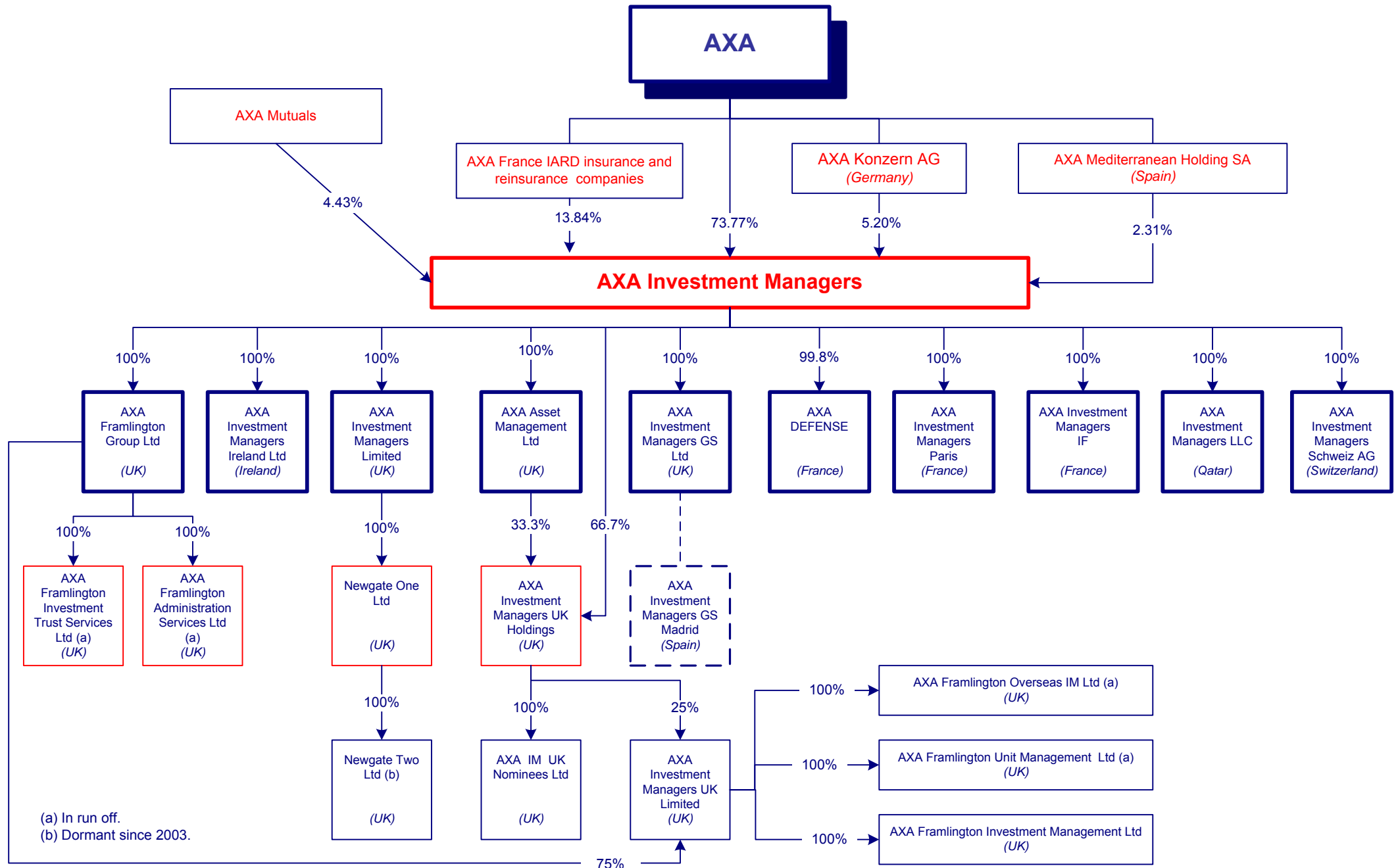

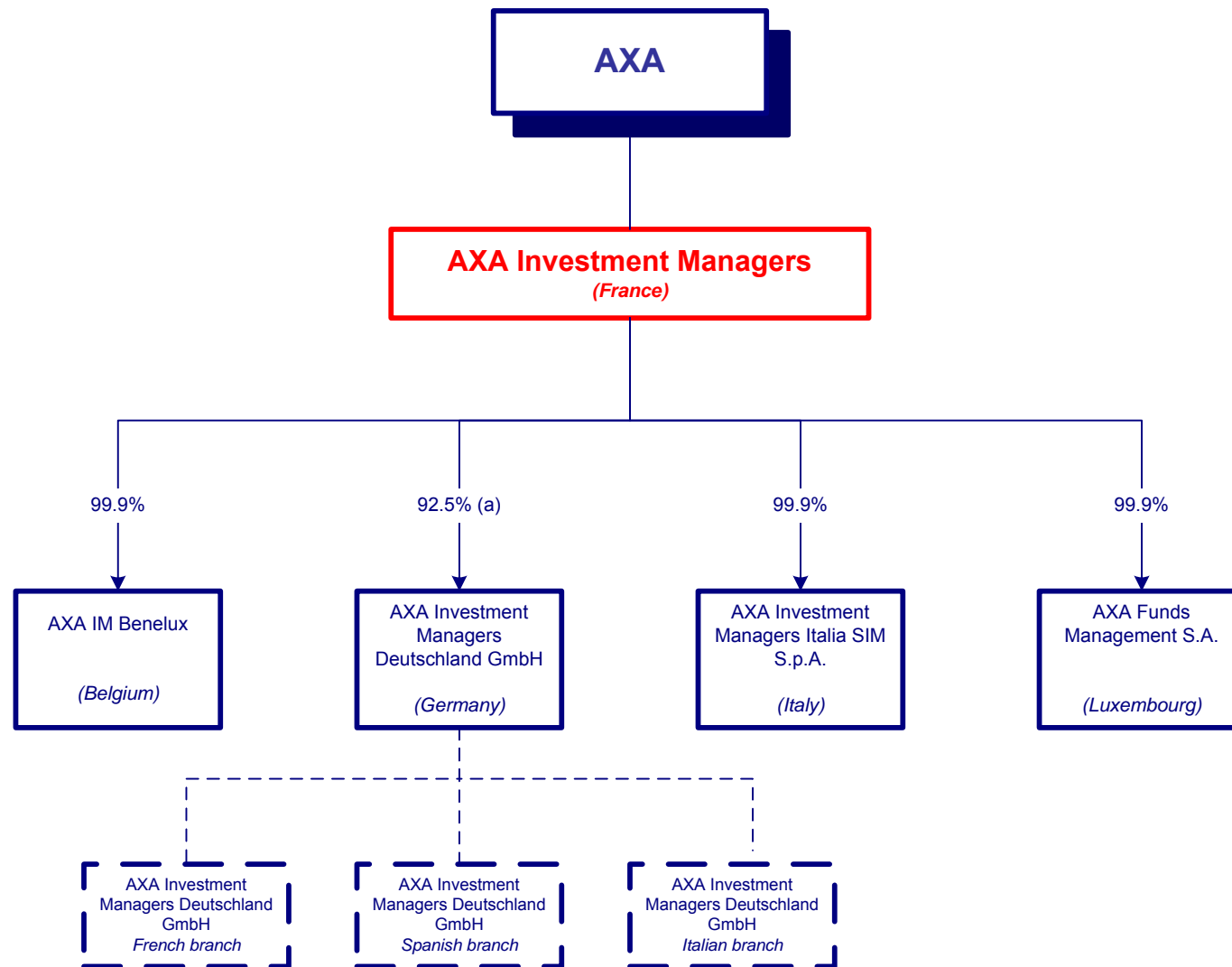

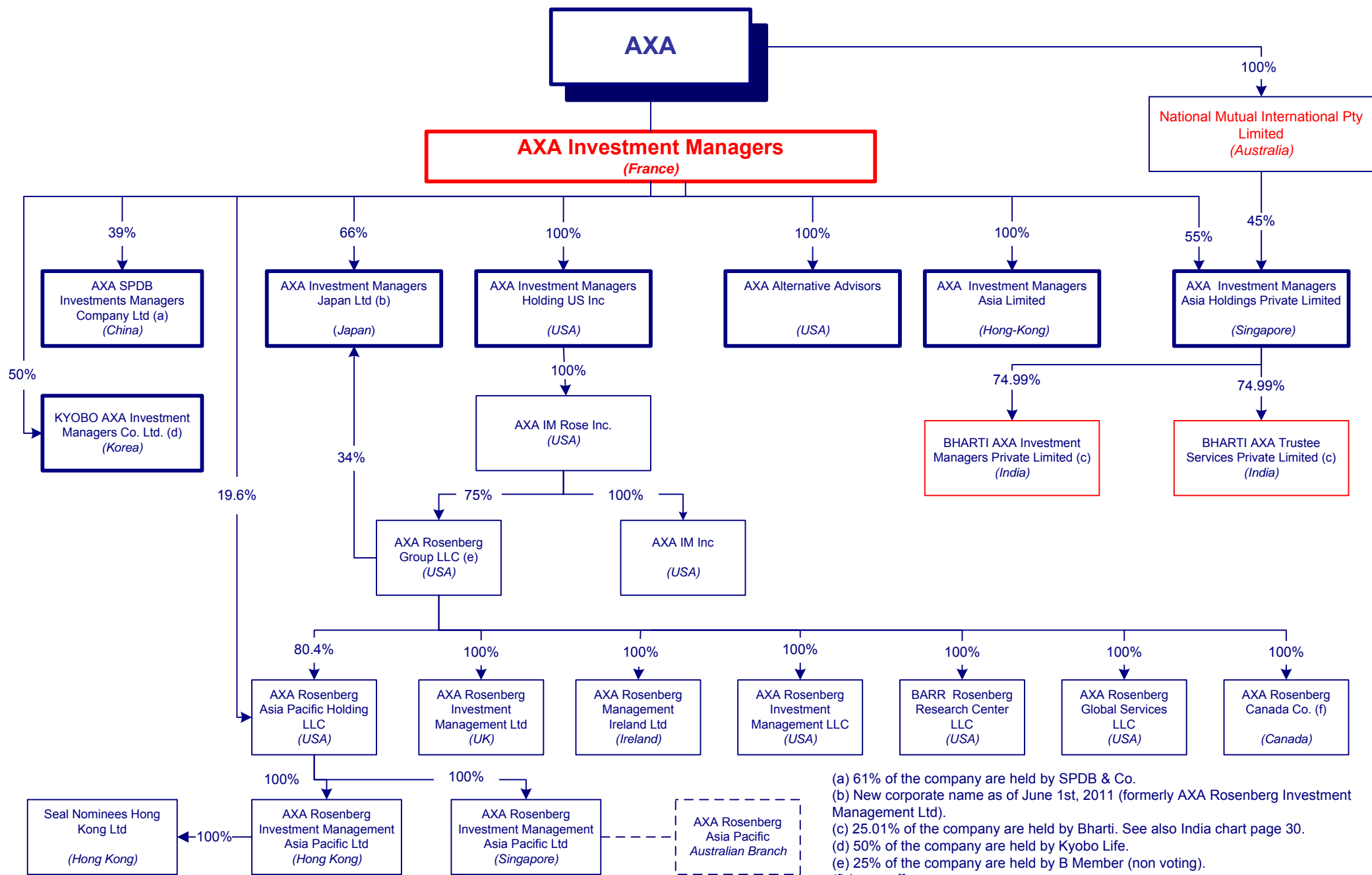

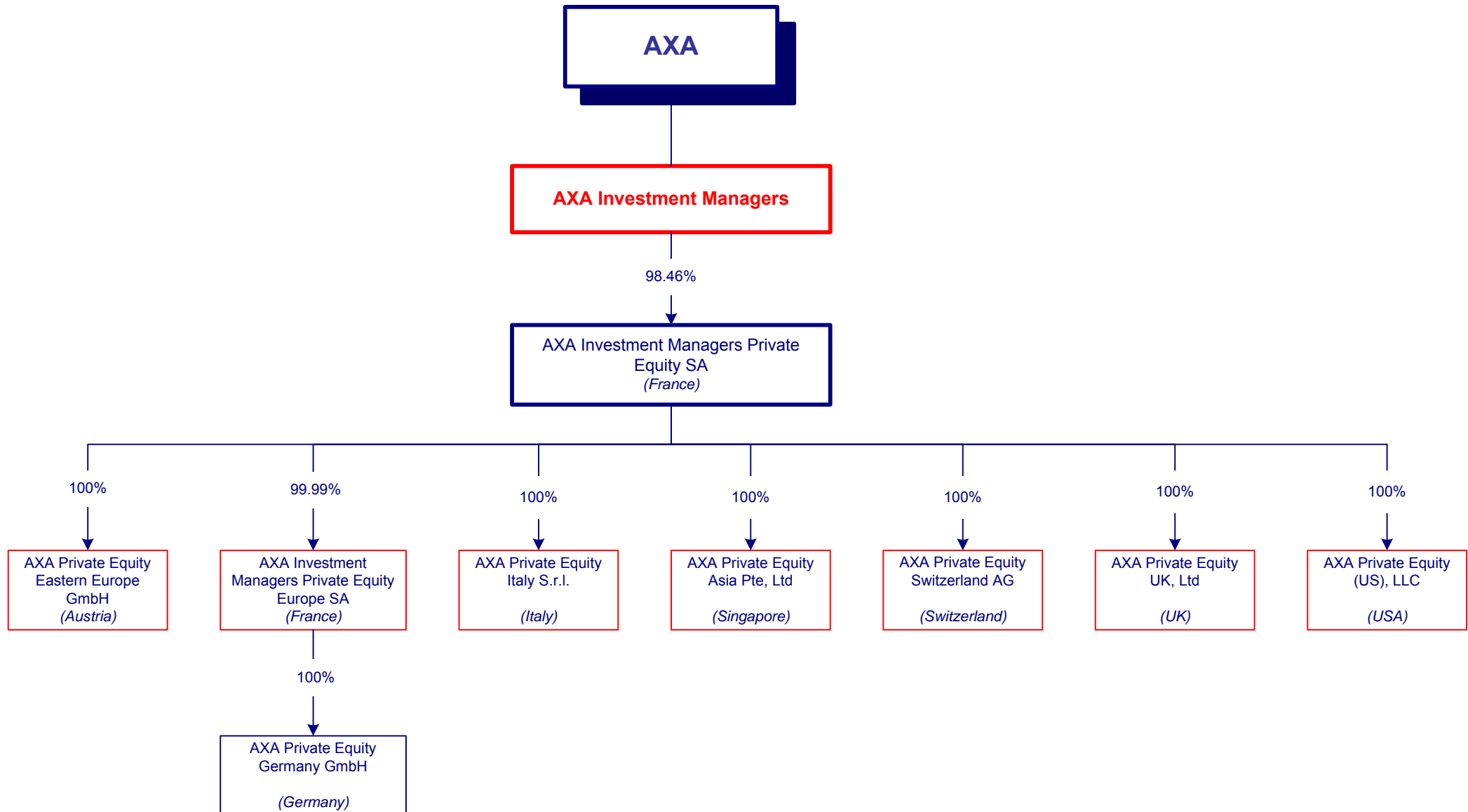

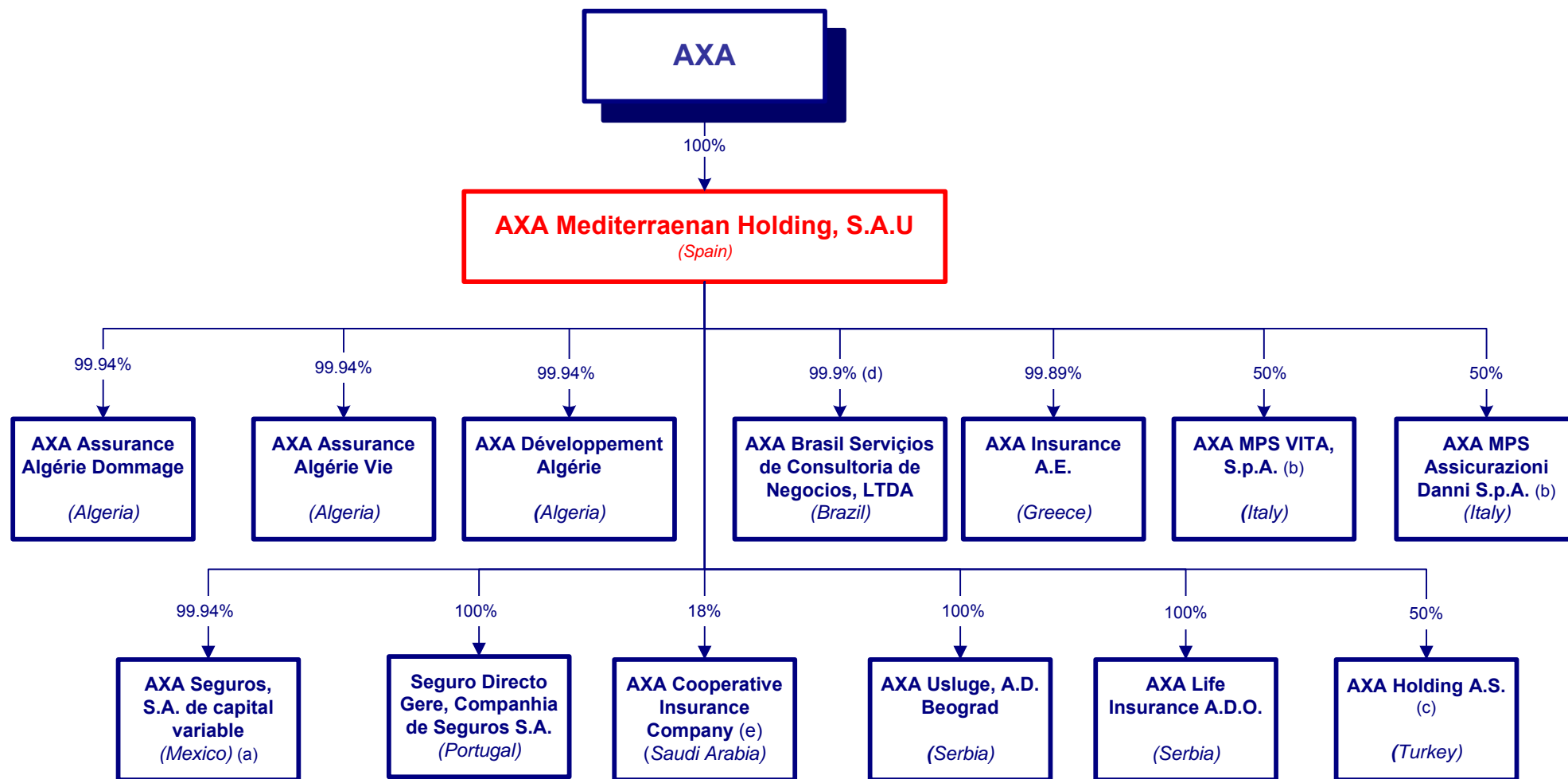

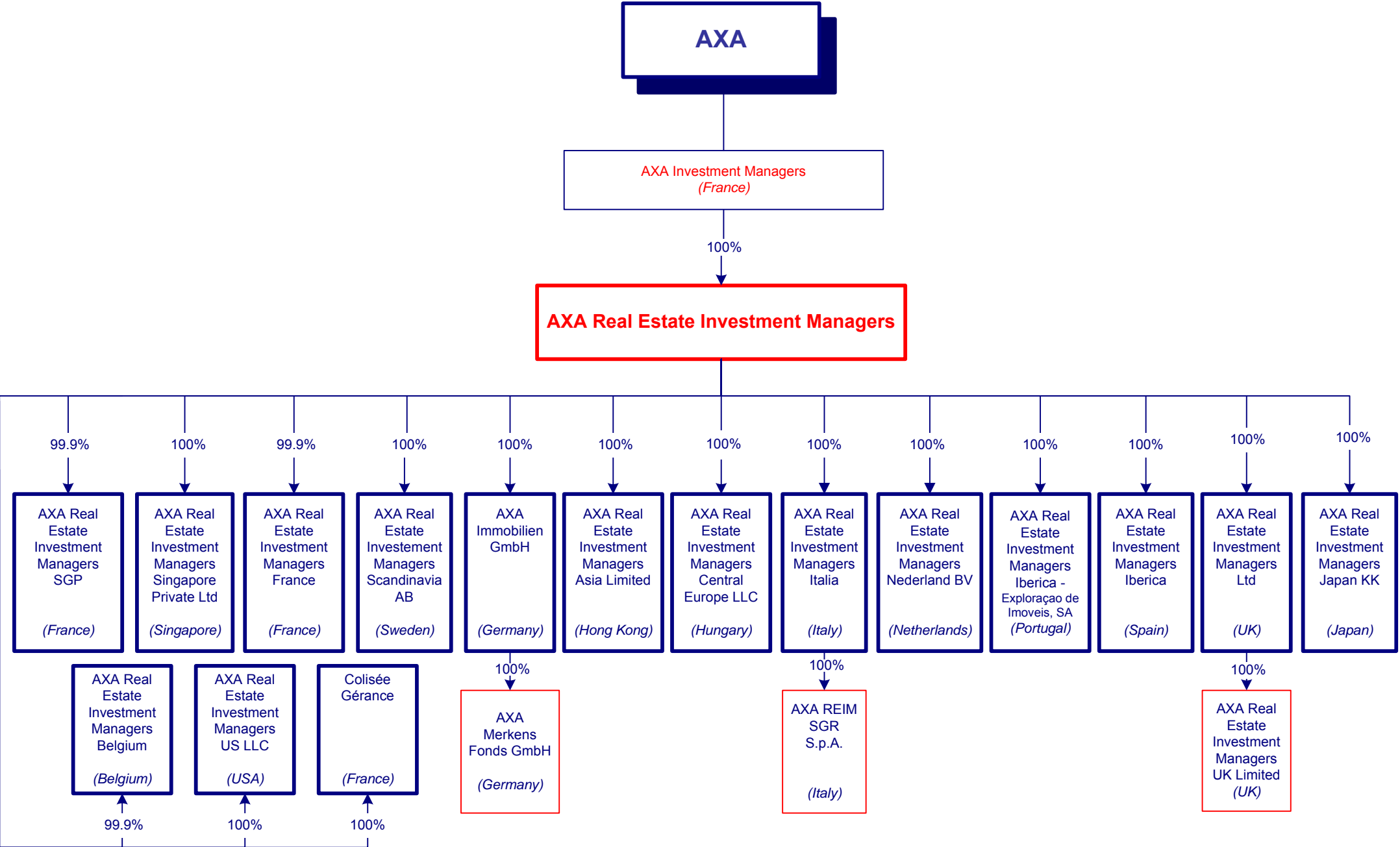

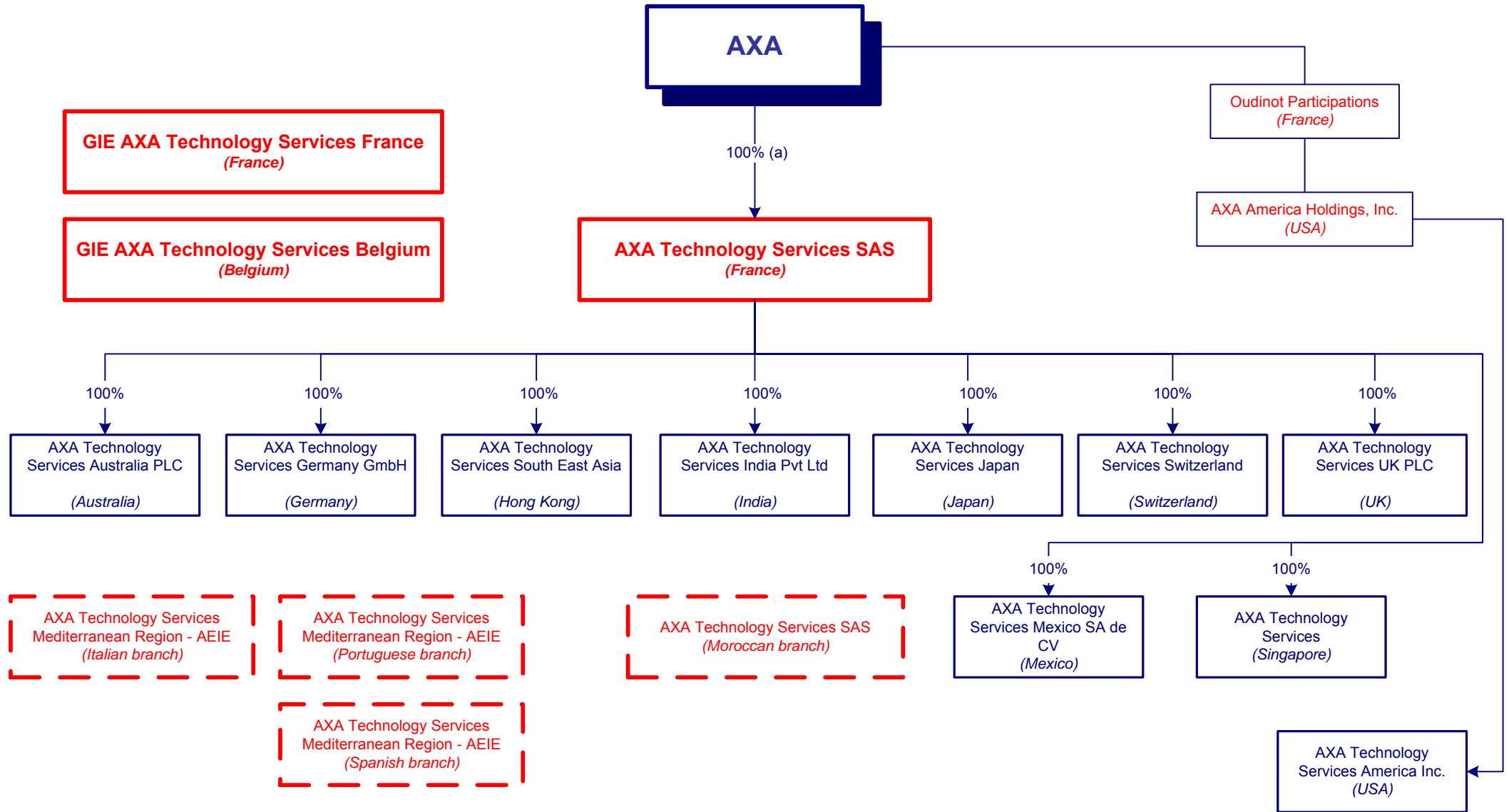

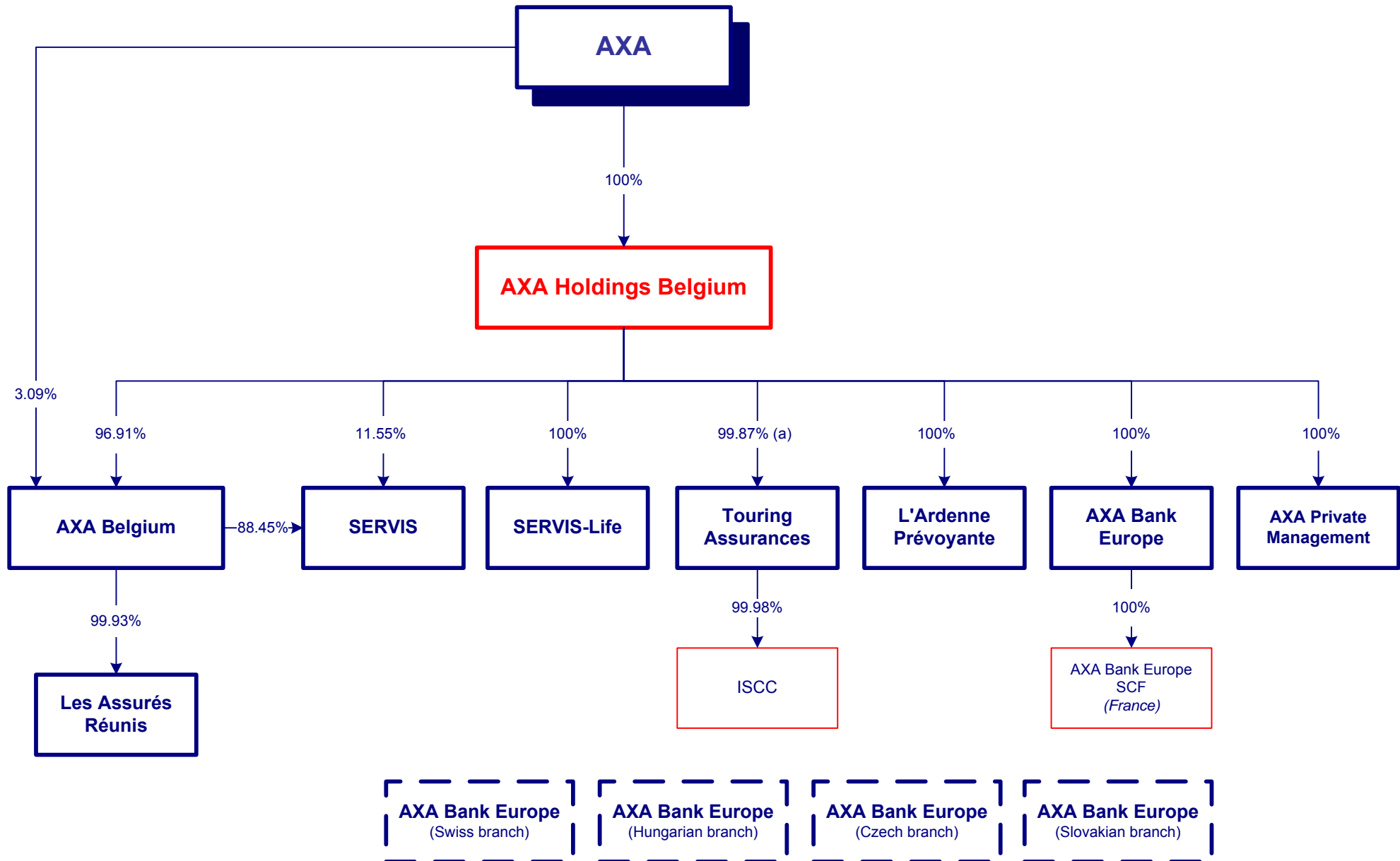

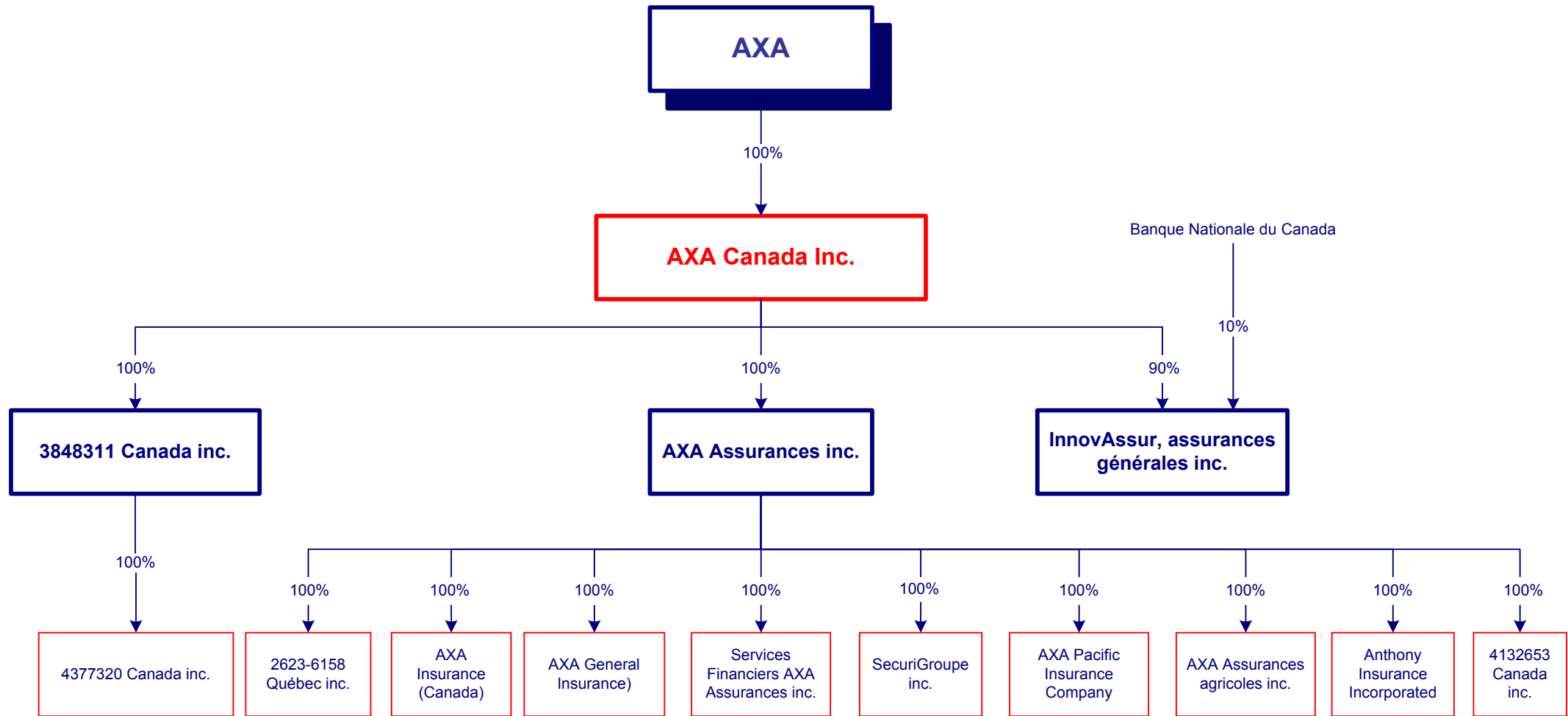

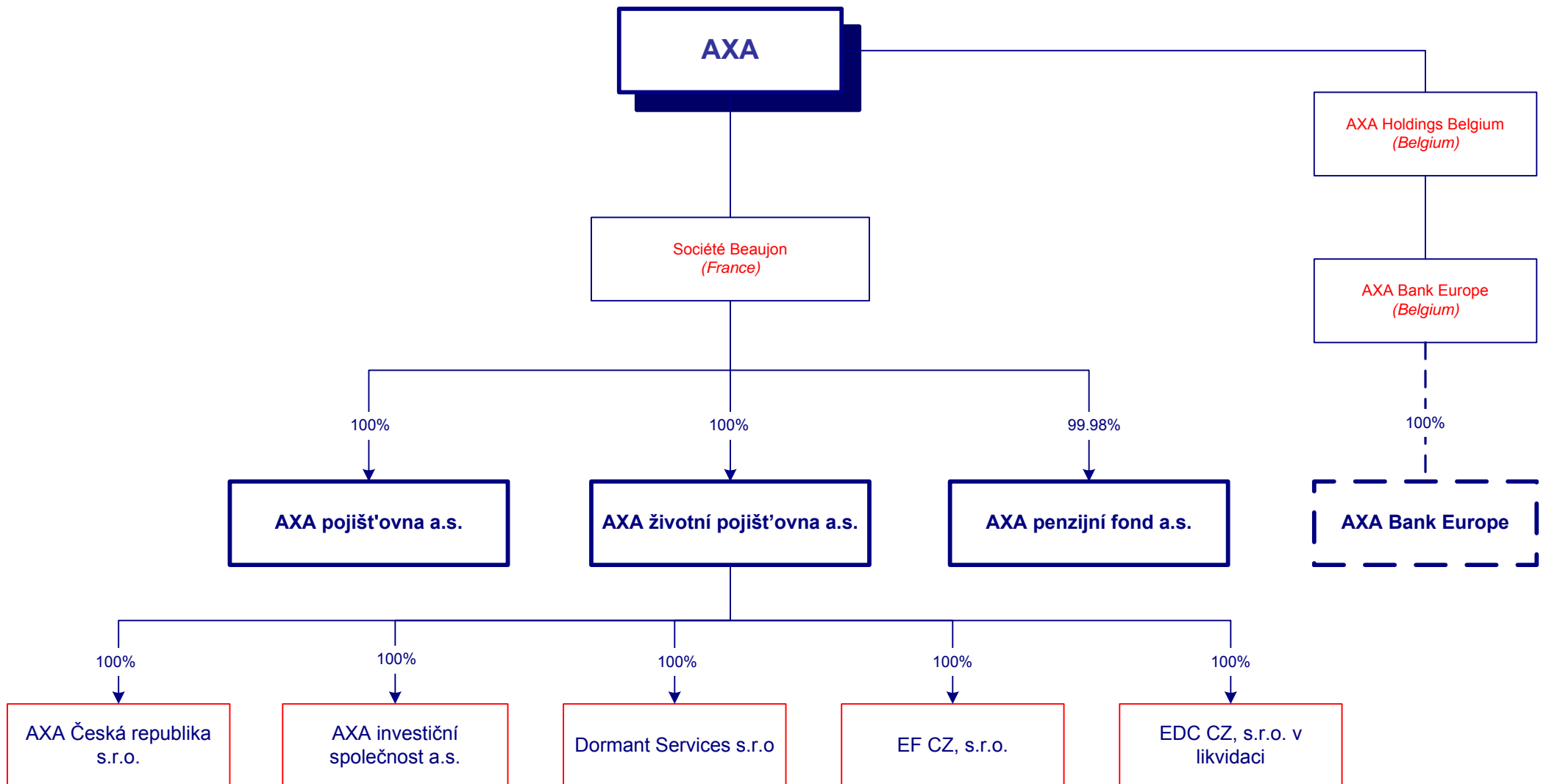

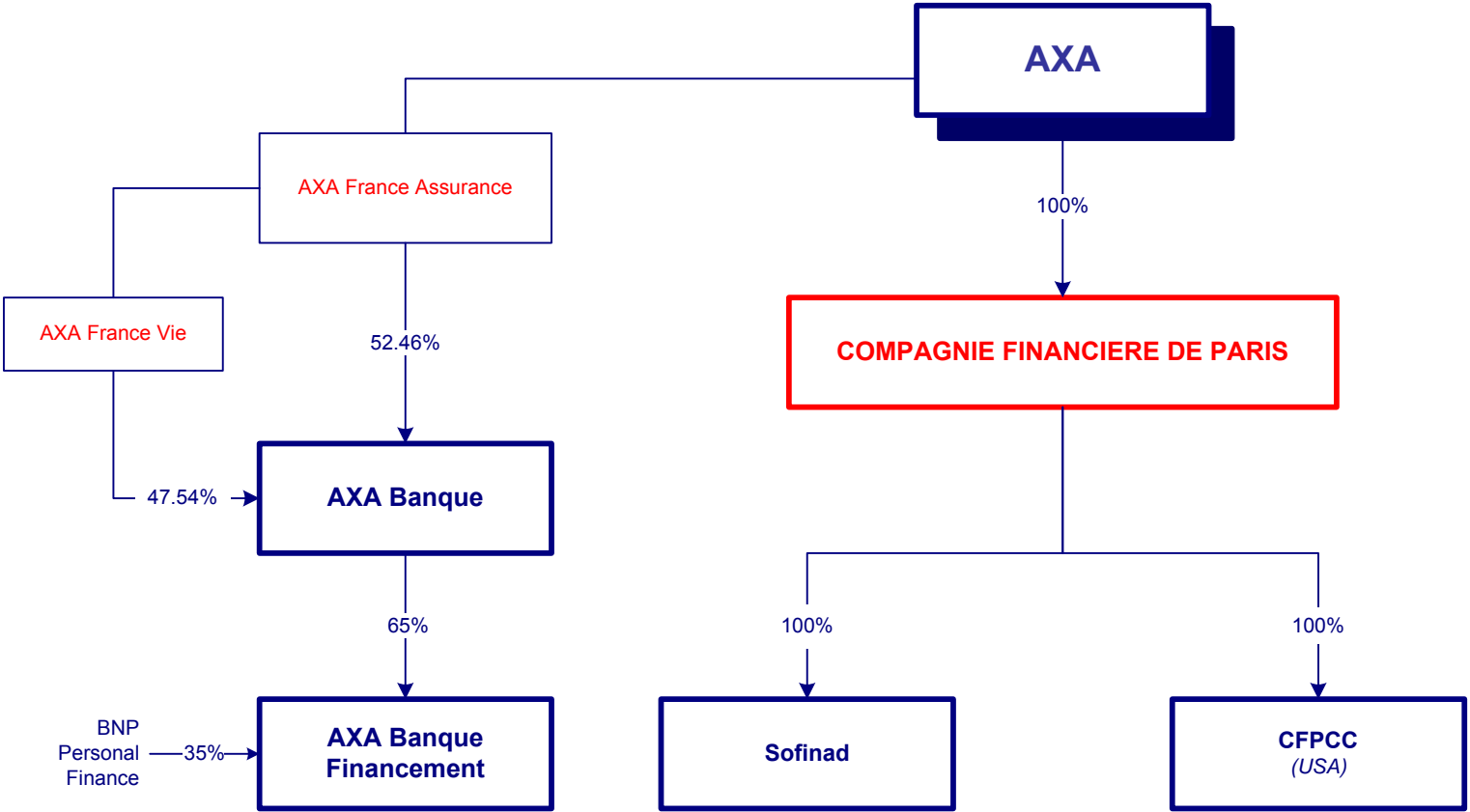

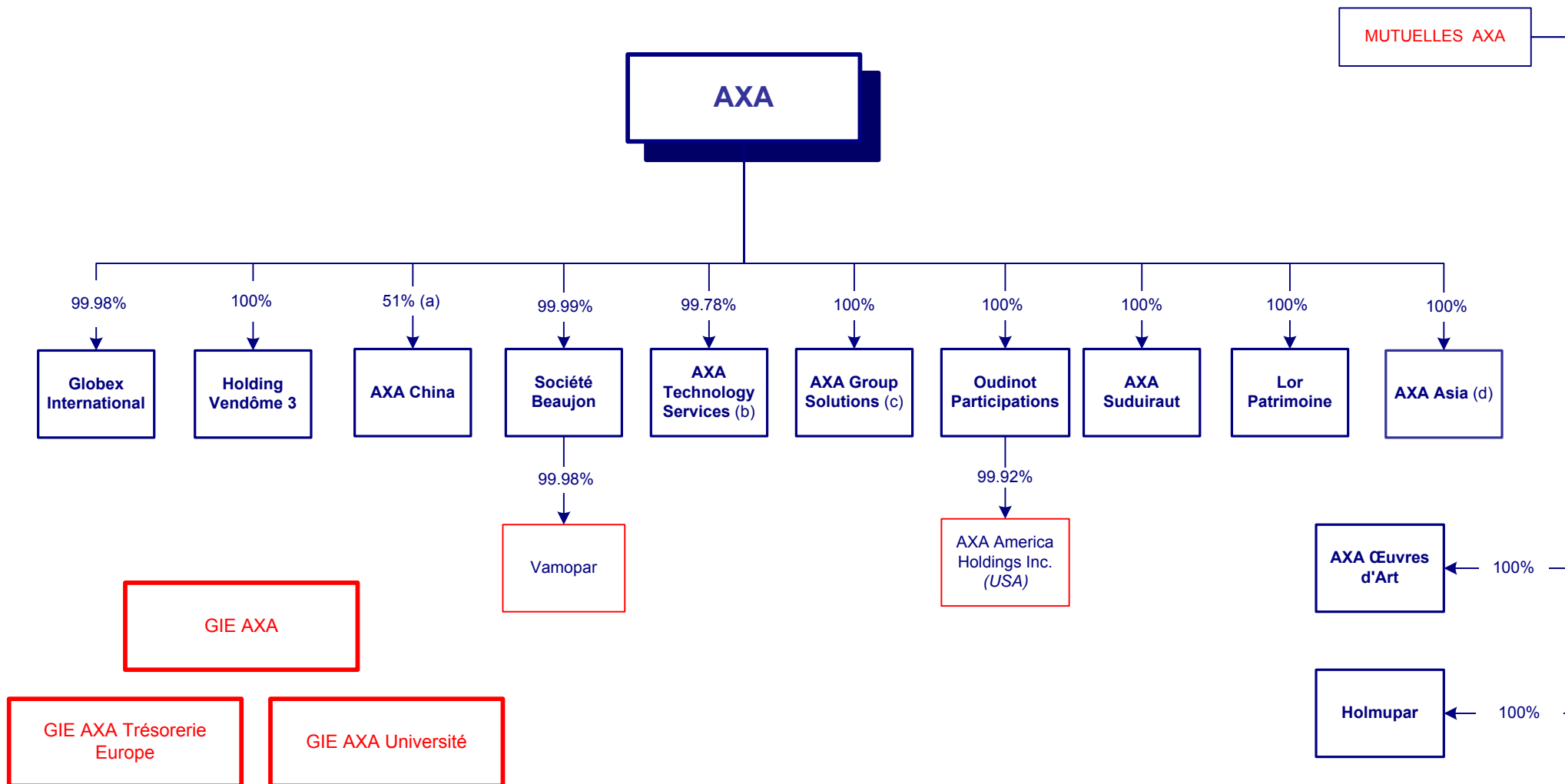
France - Financial companies

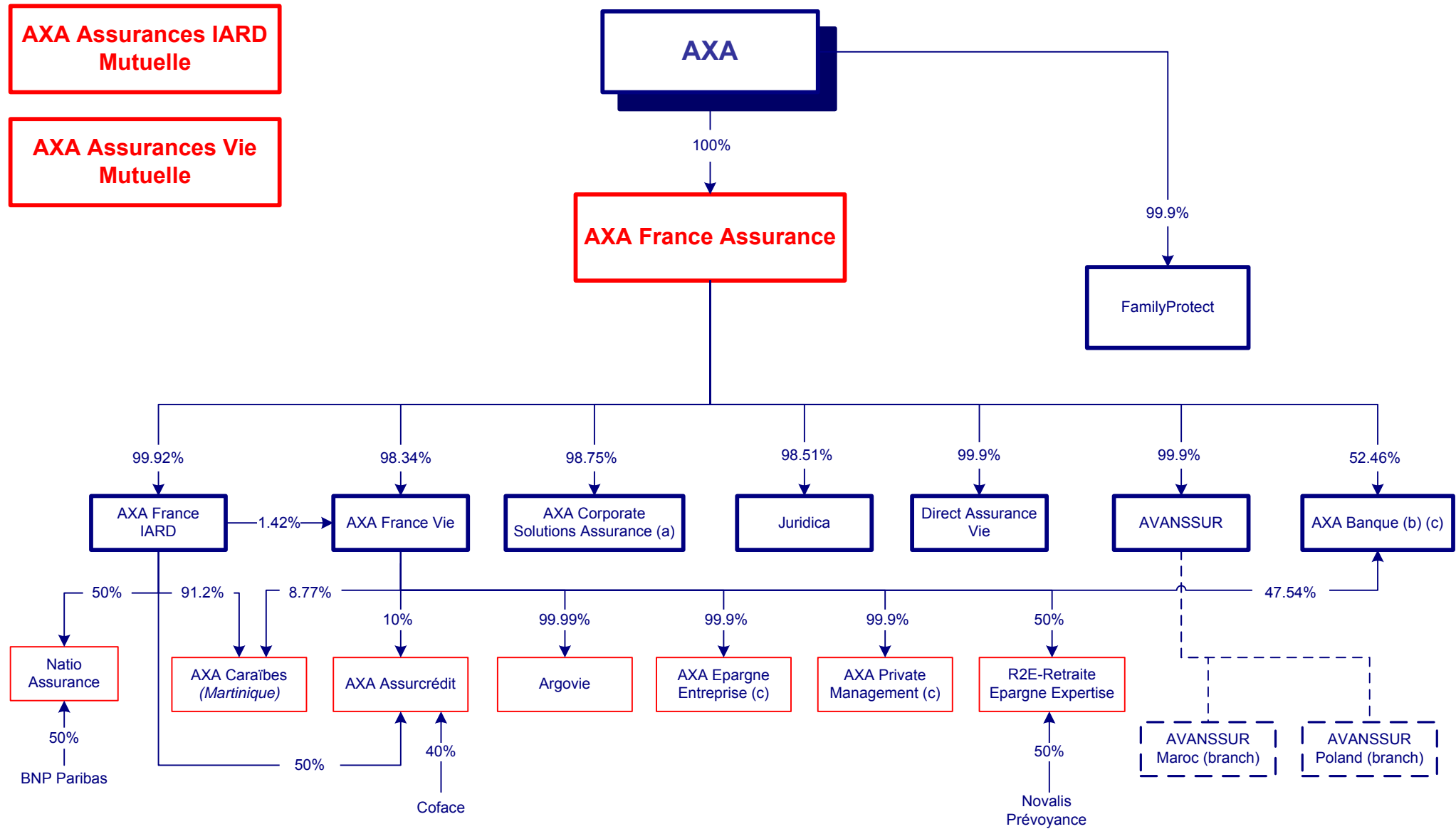

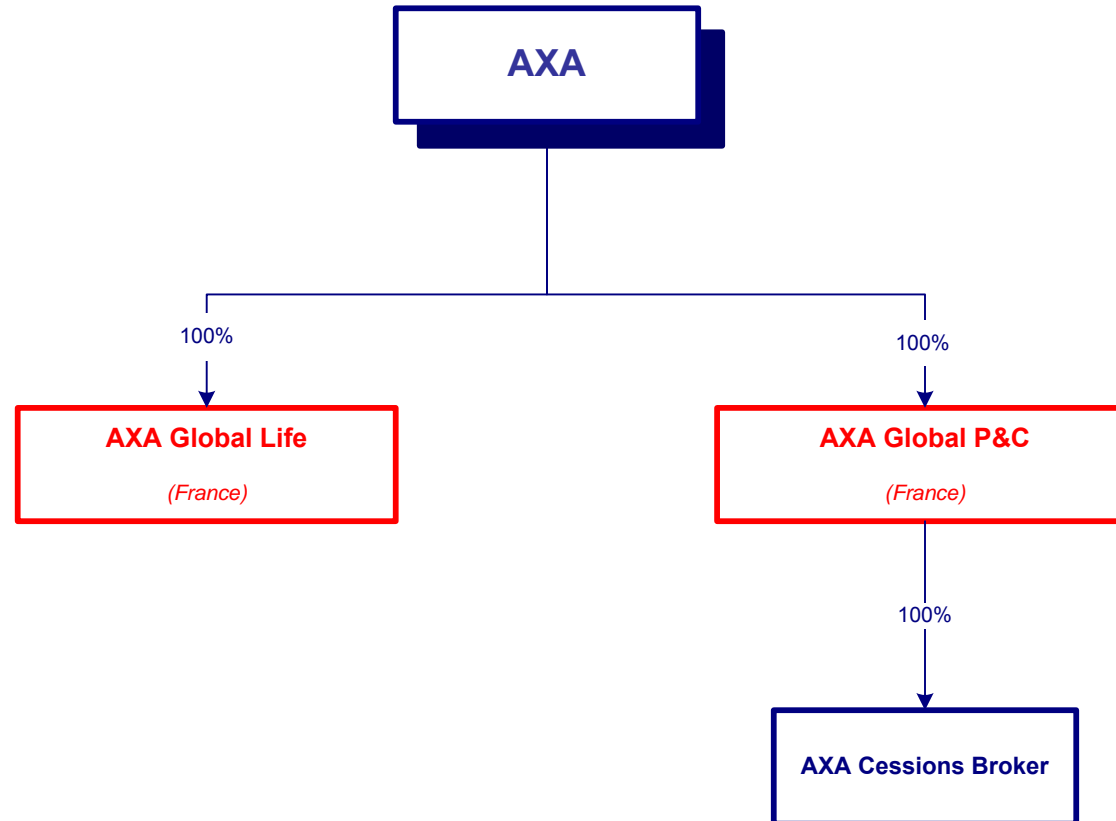

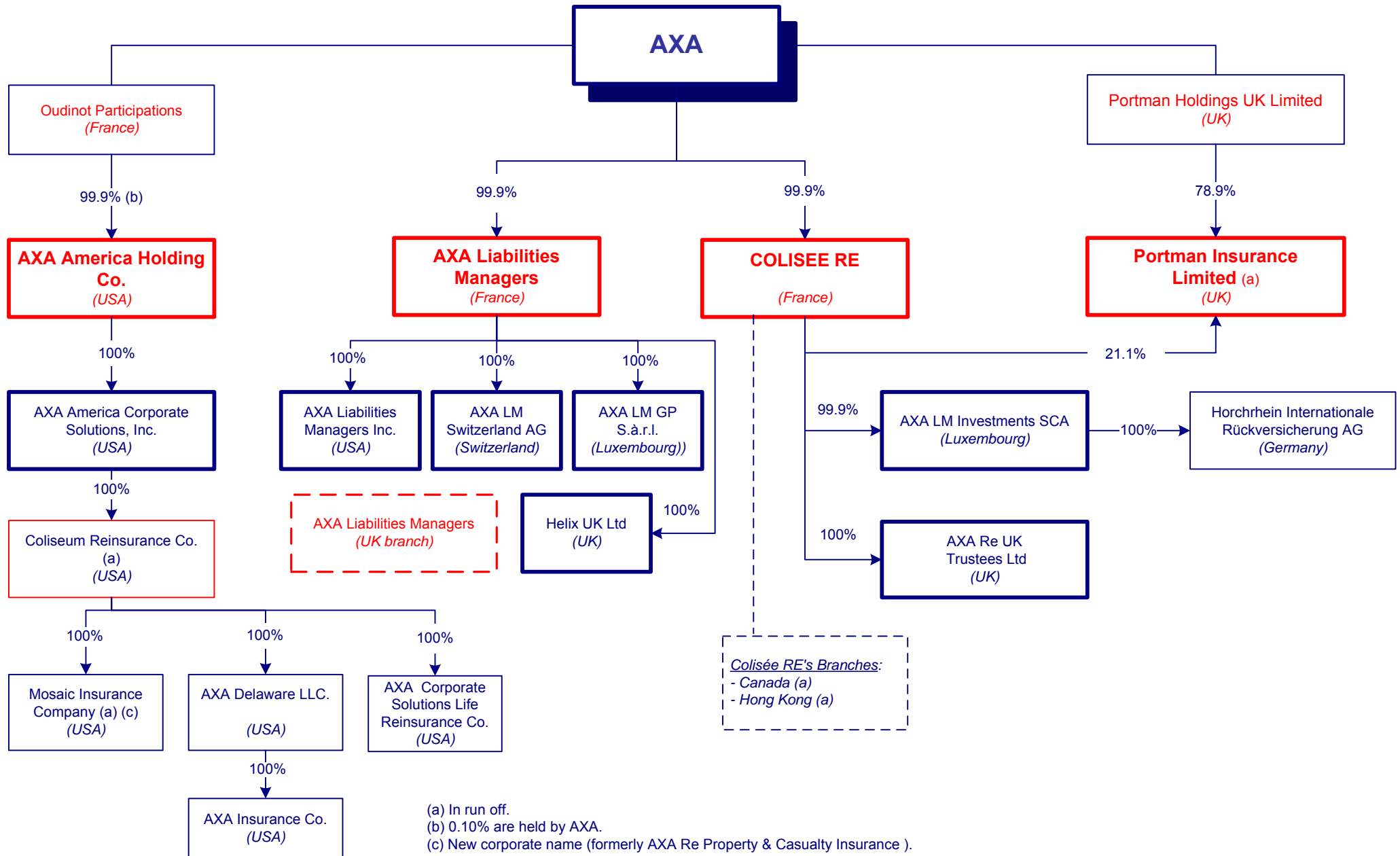
France – Reinsurance companies (global lines)

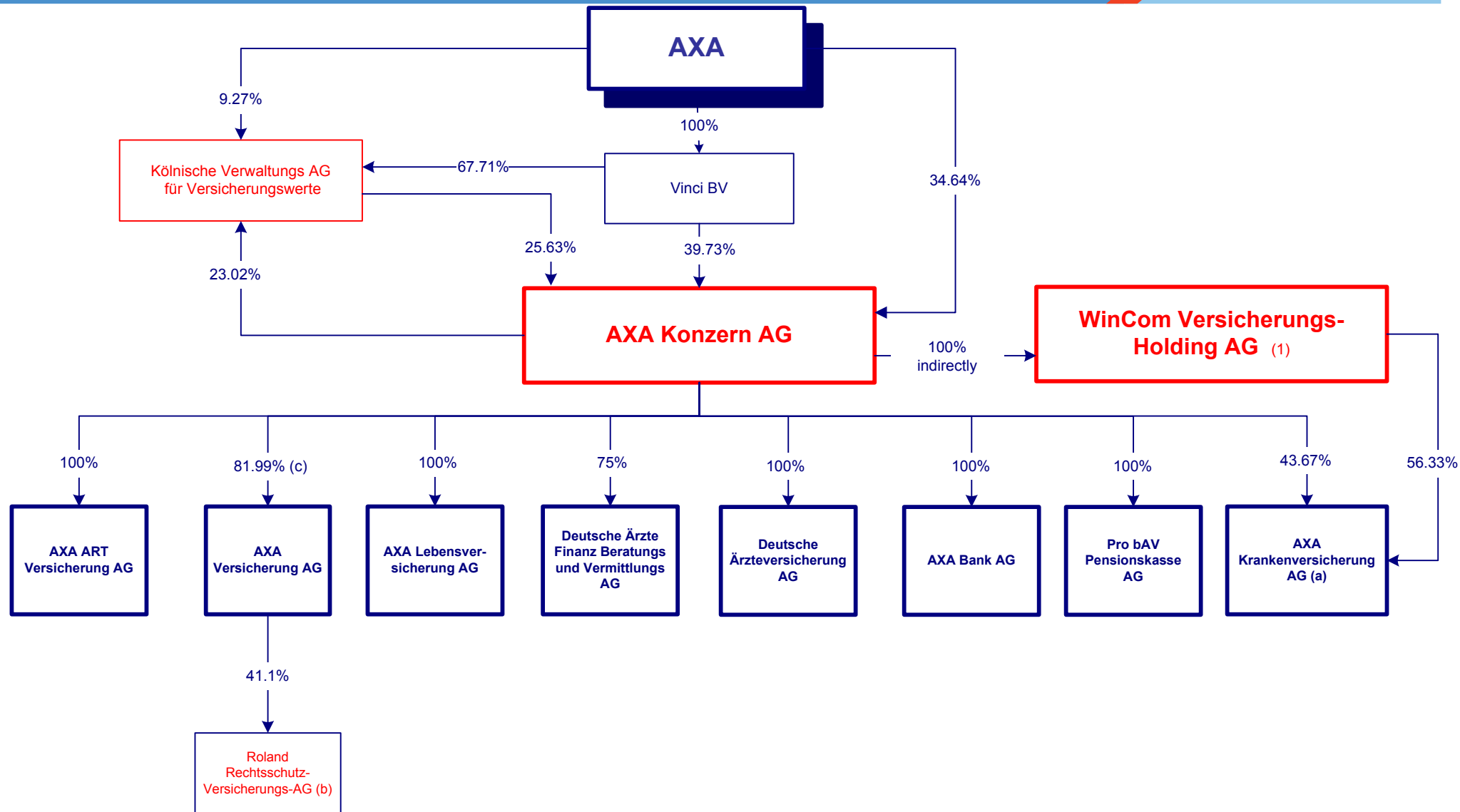

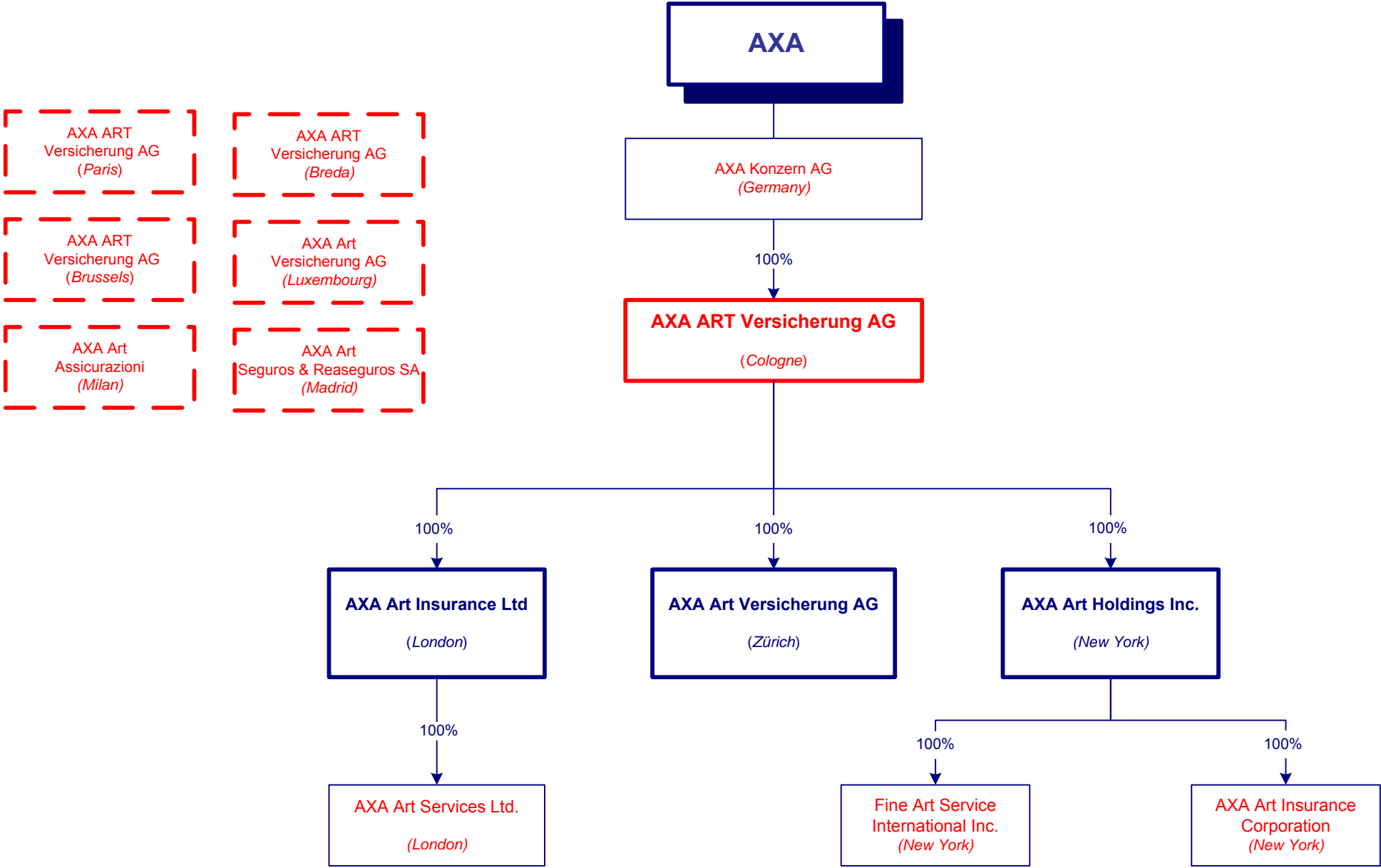

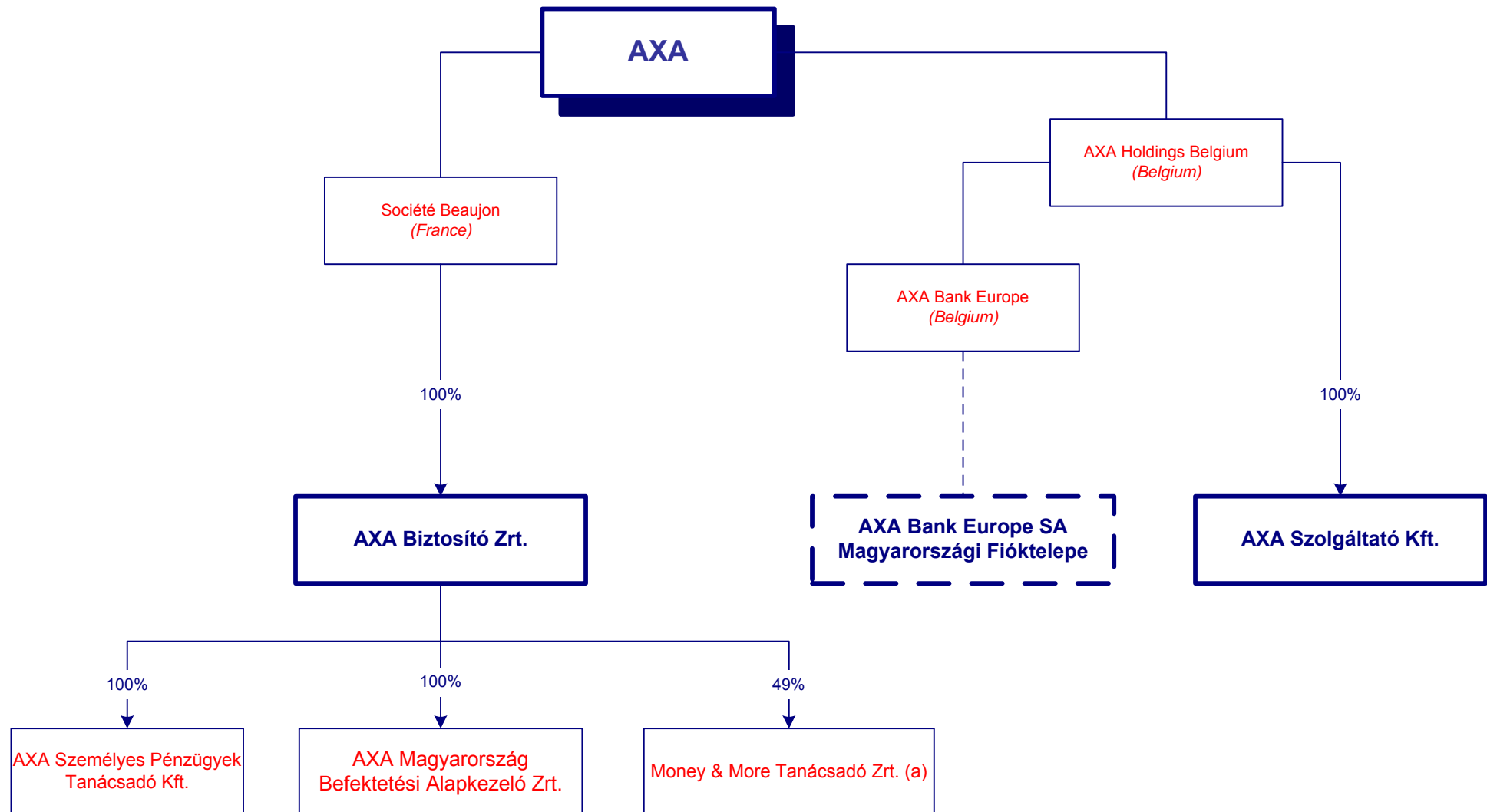
Germany - ART insurance companies

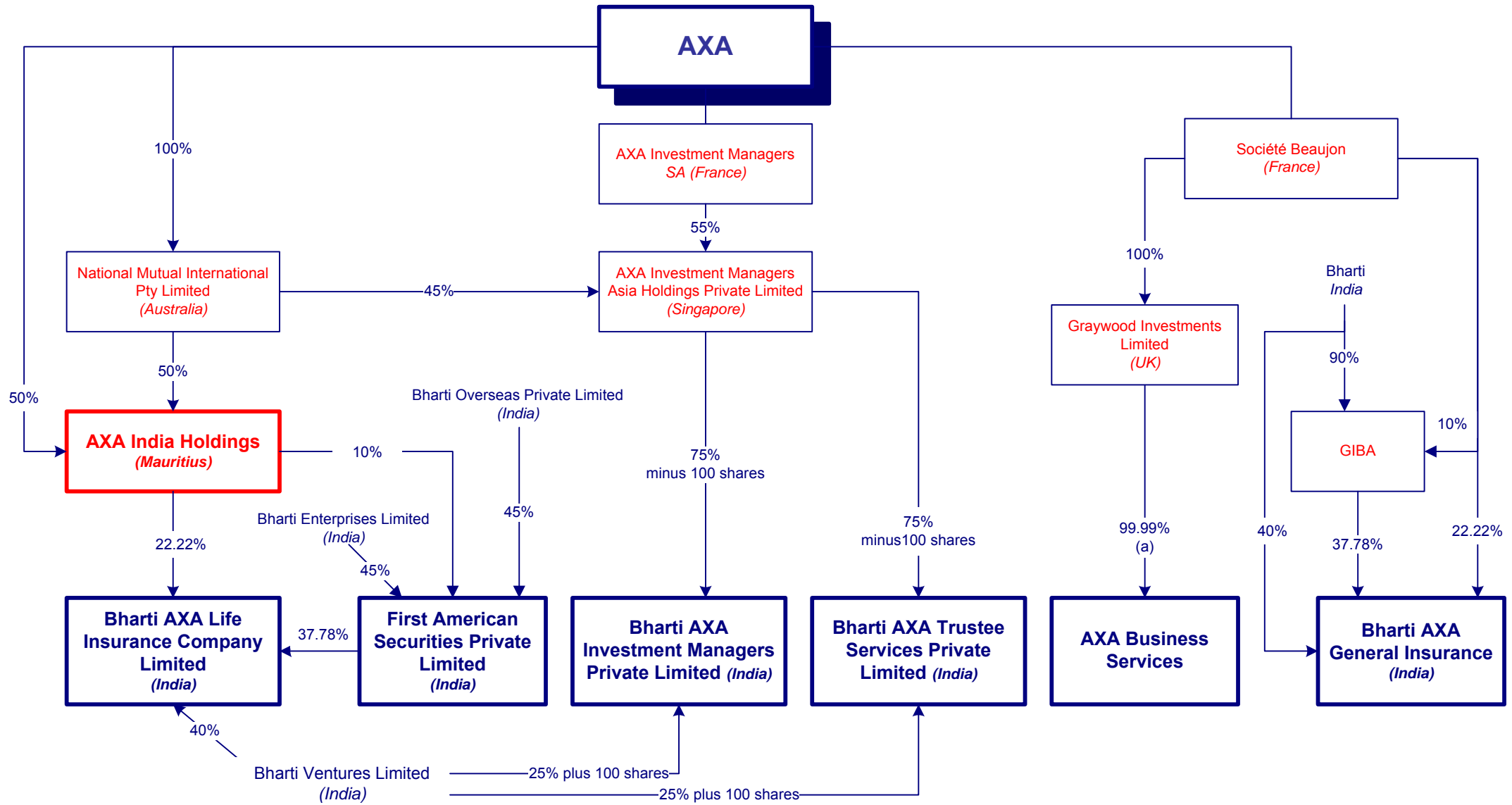

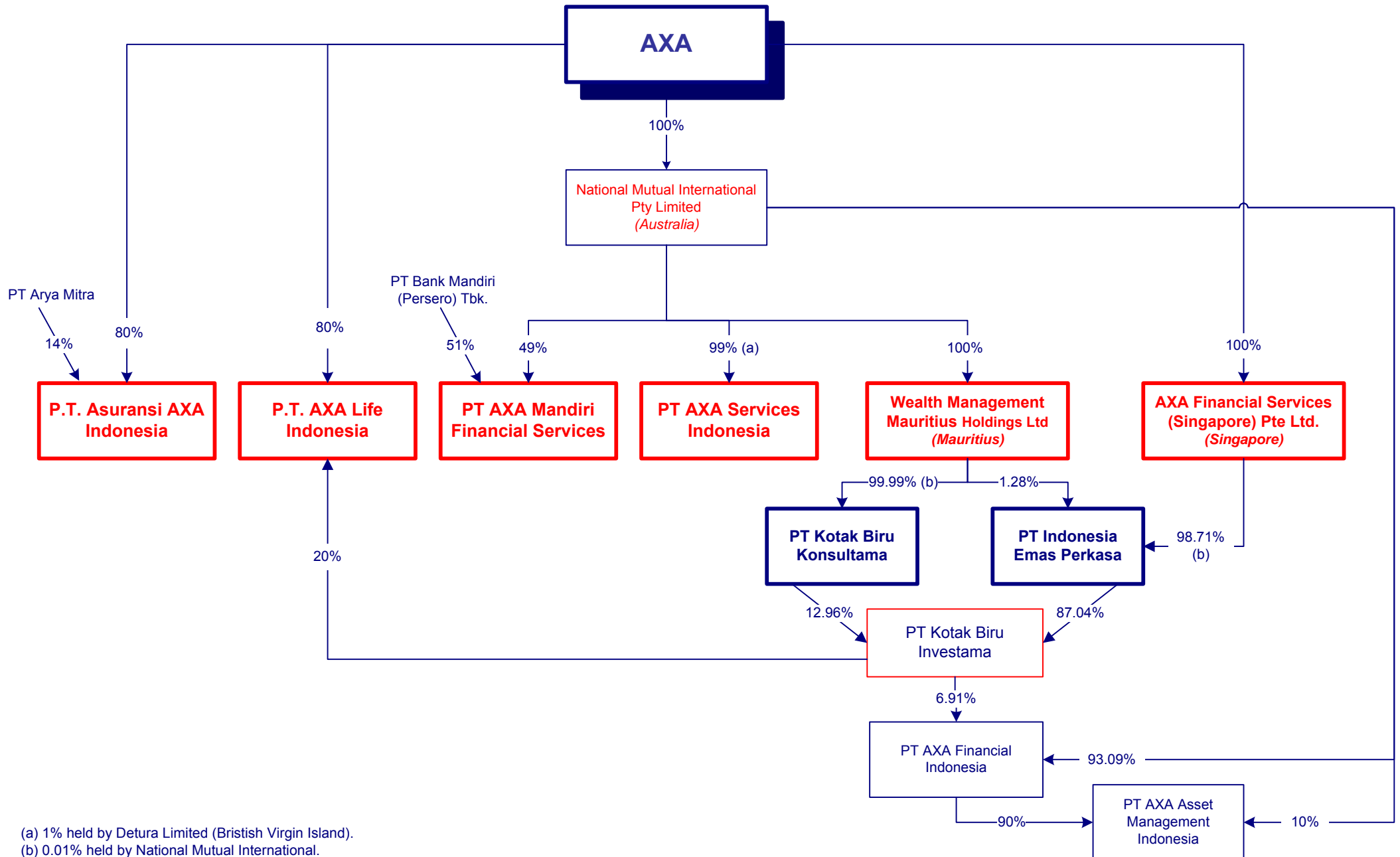

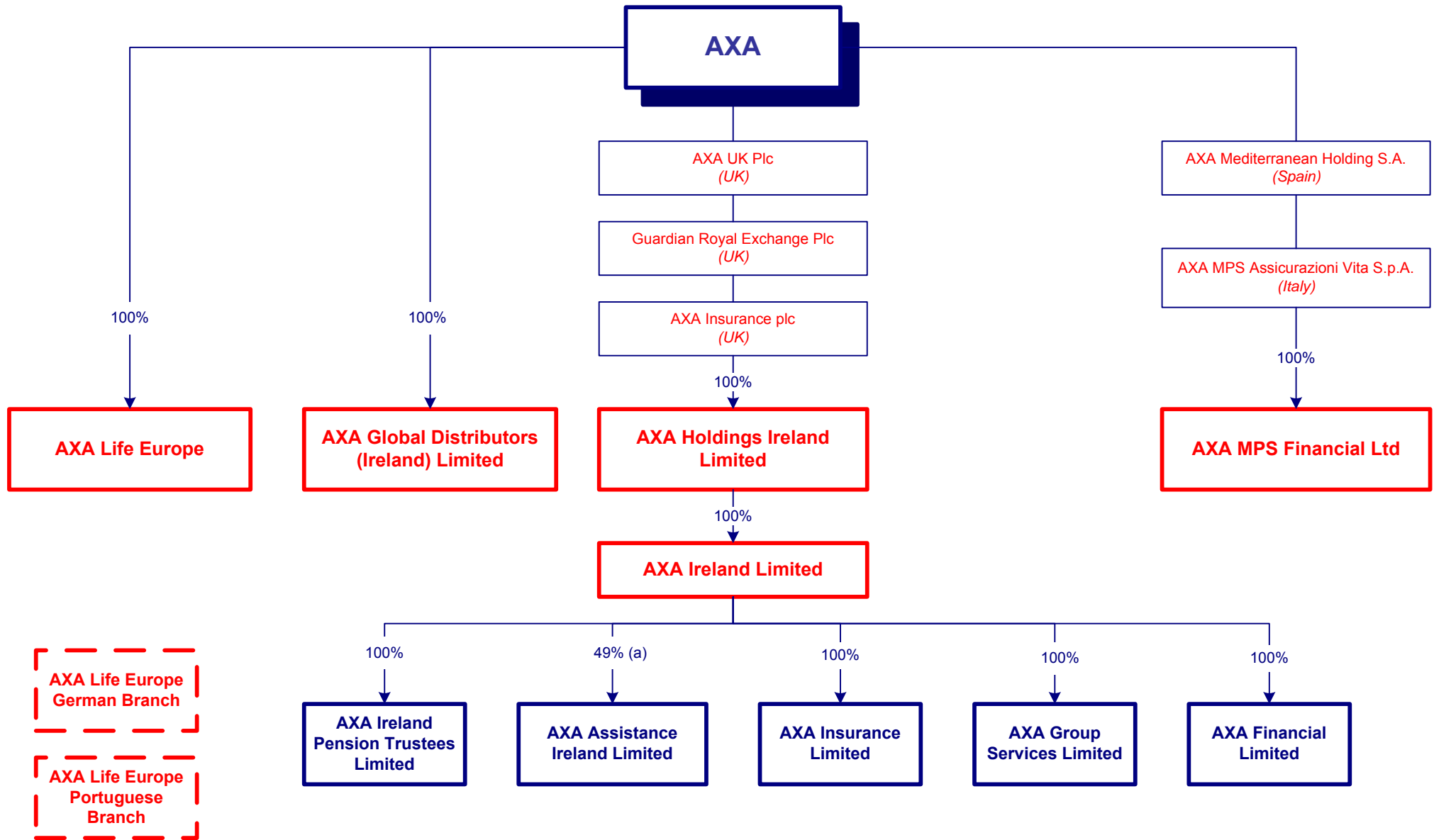

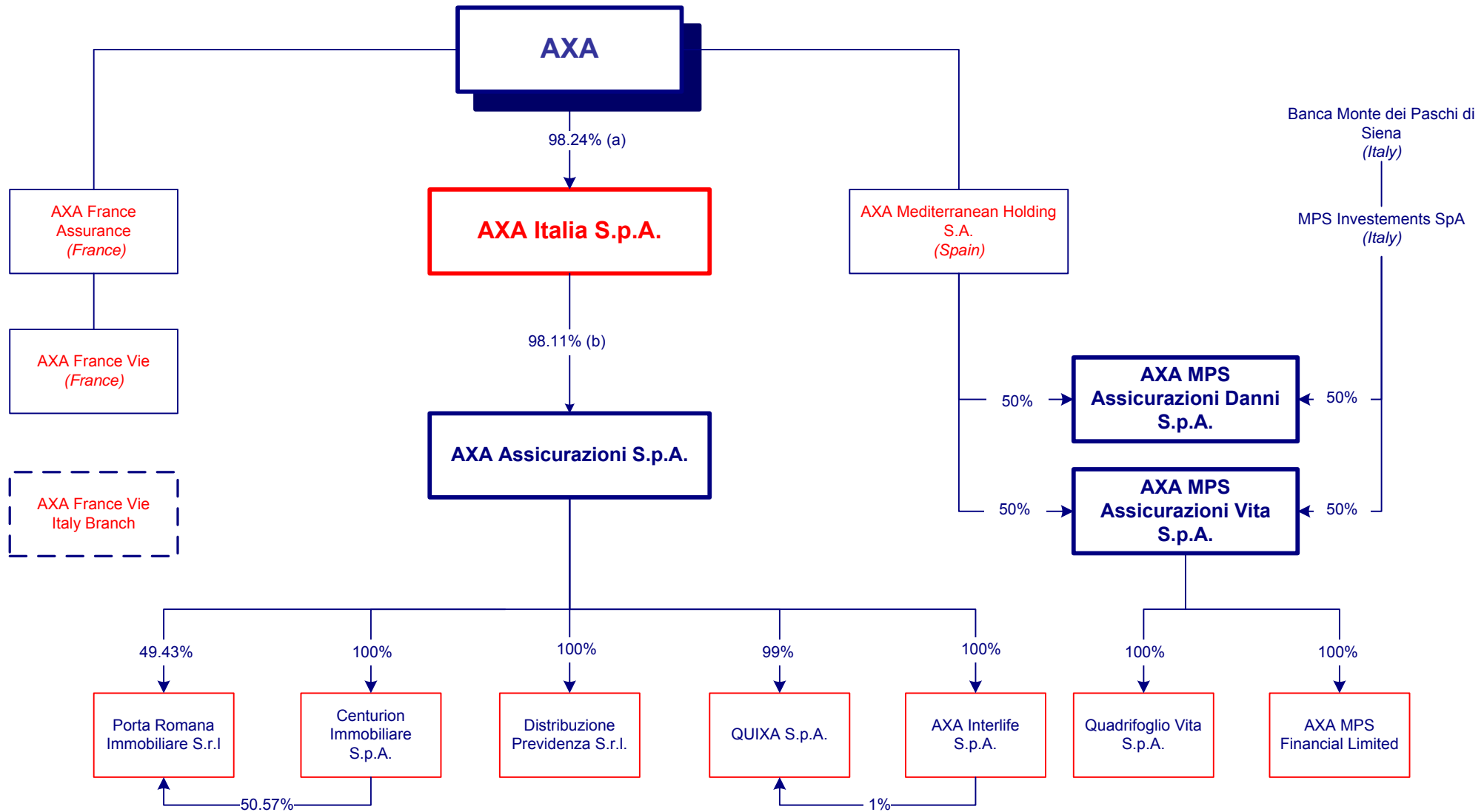

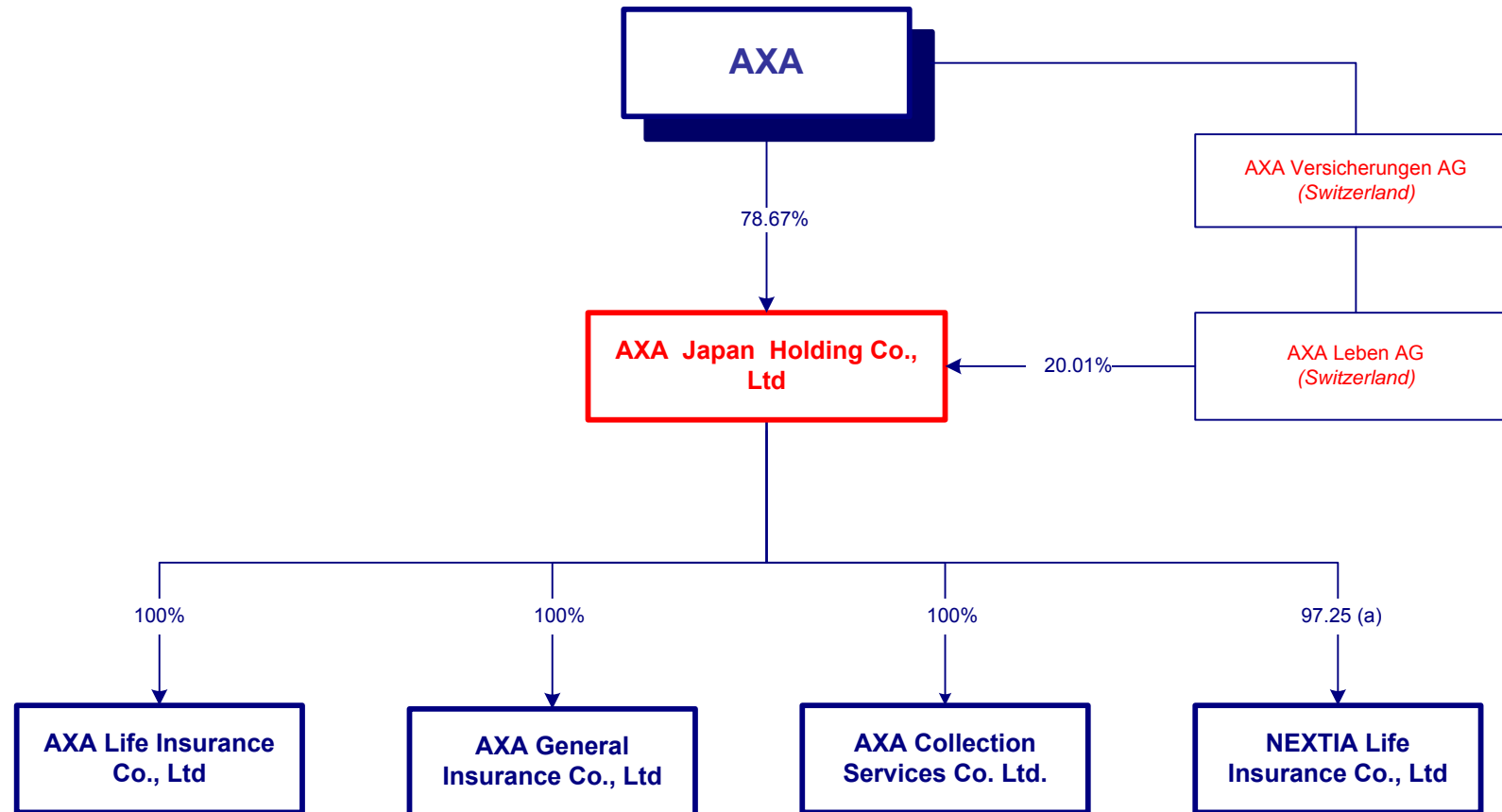

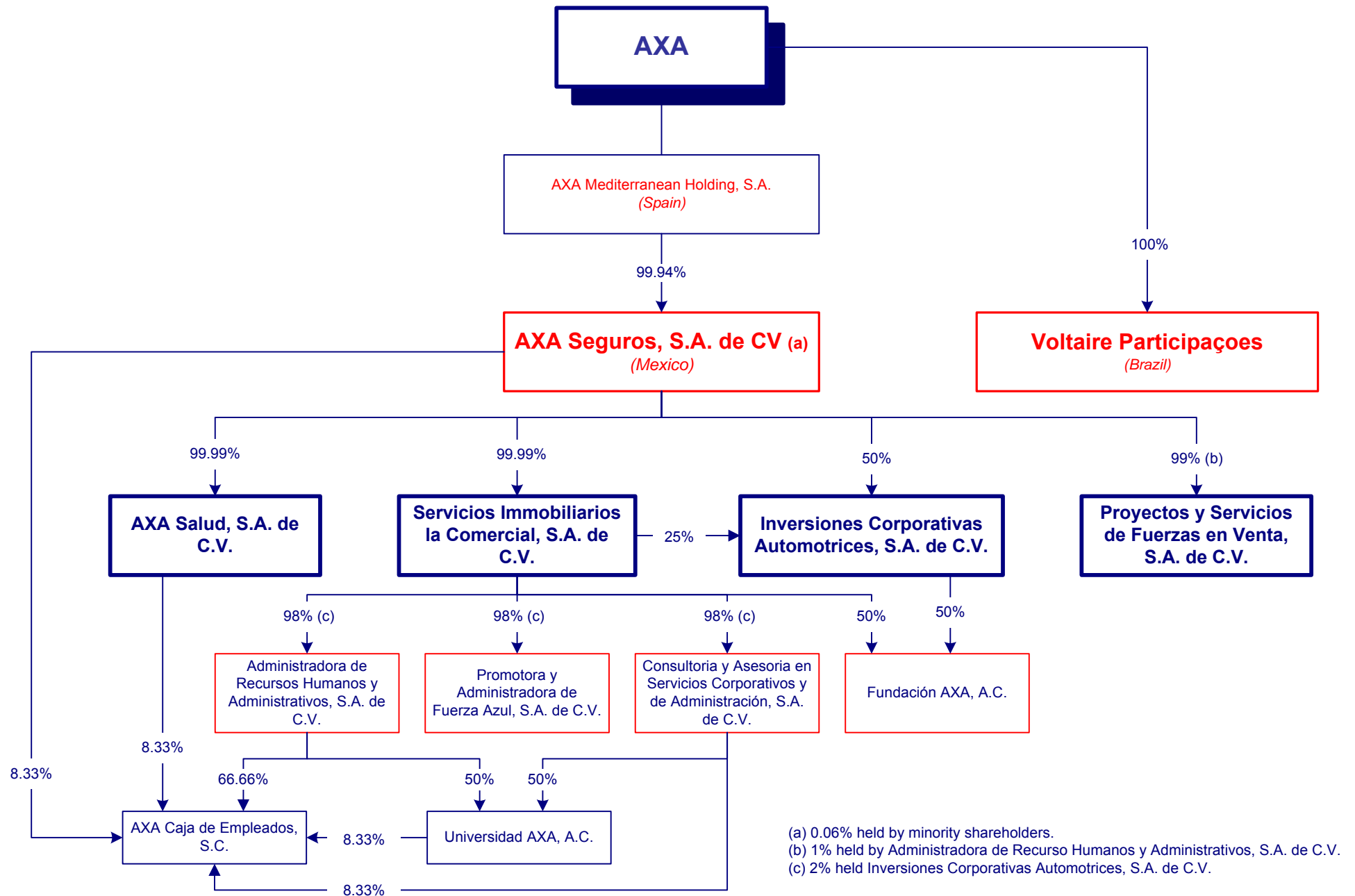

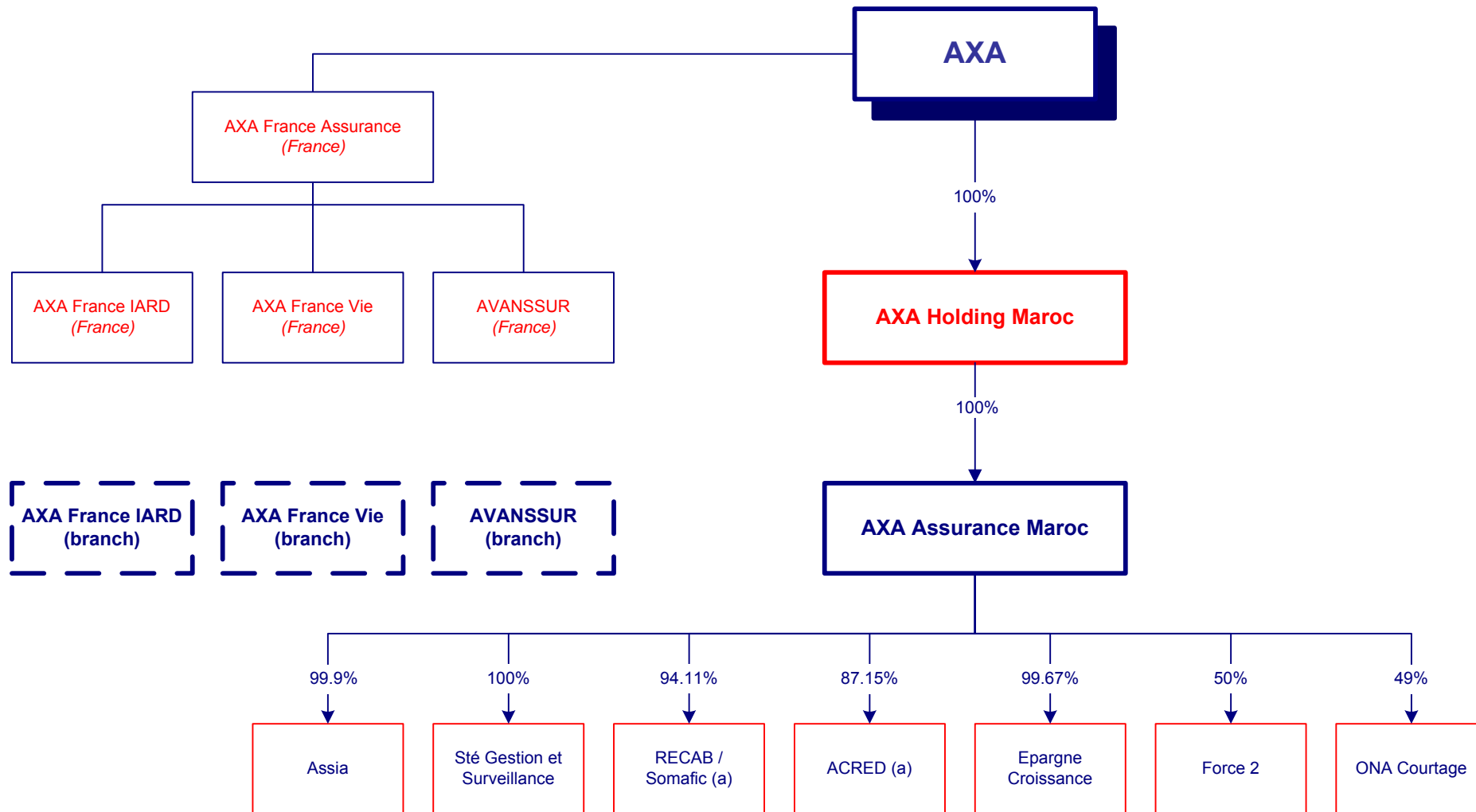

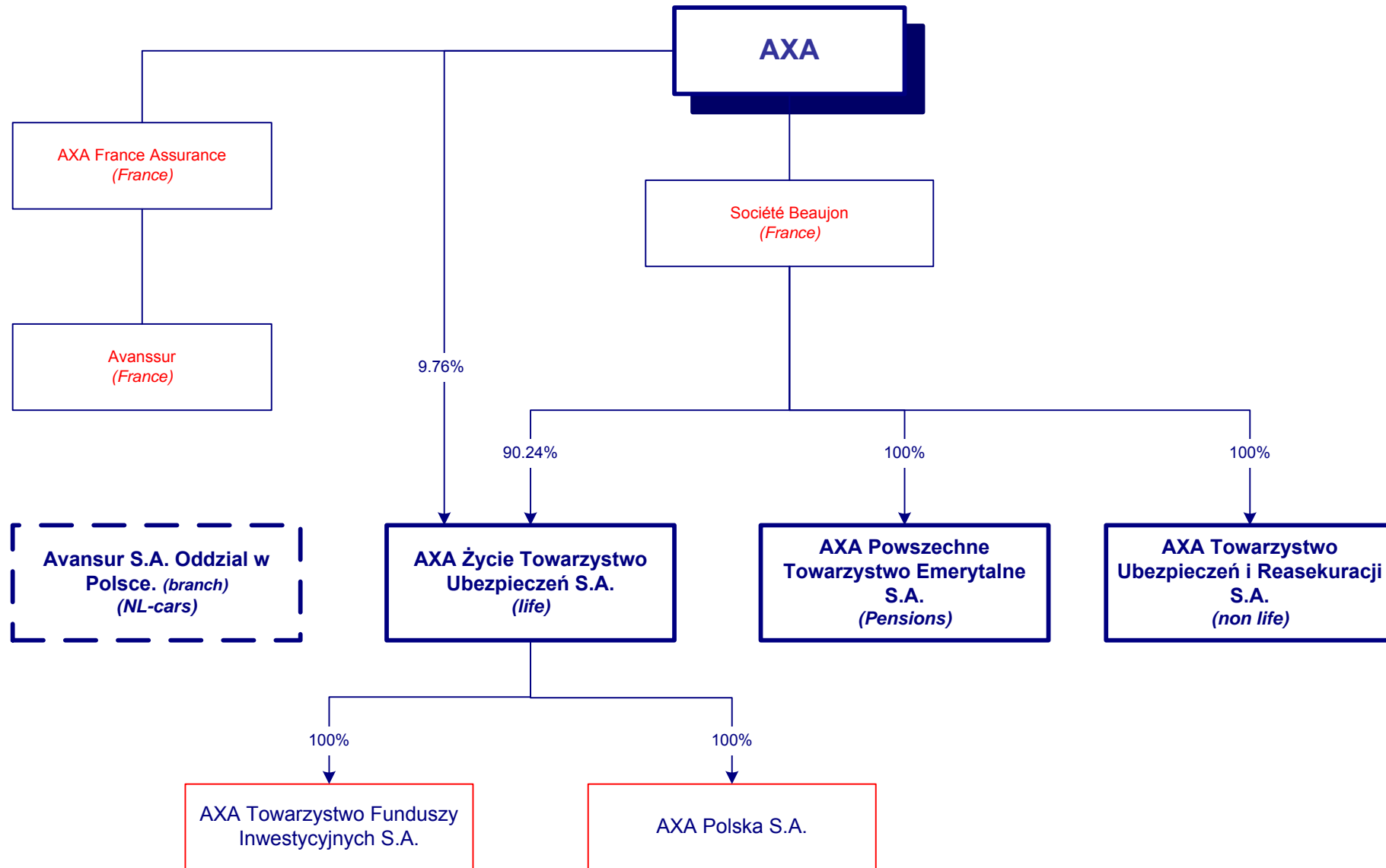

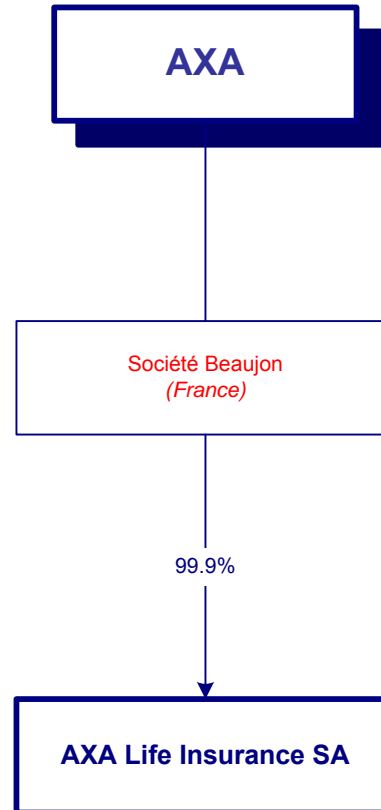

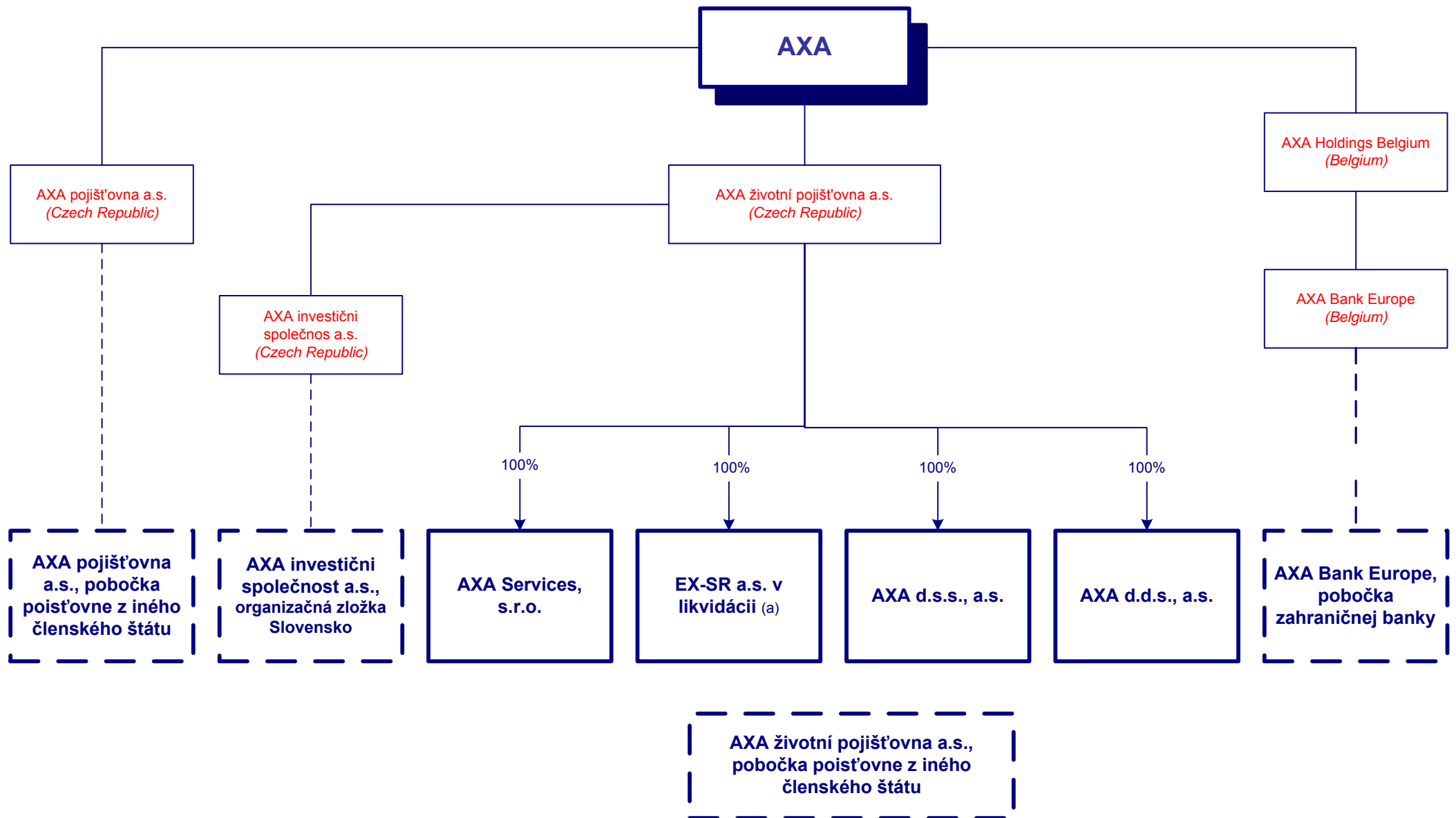

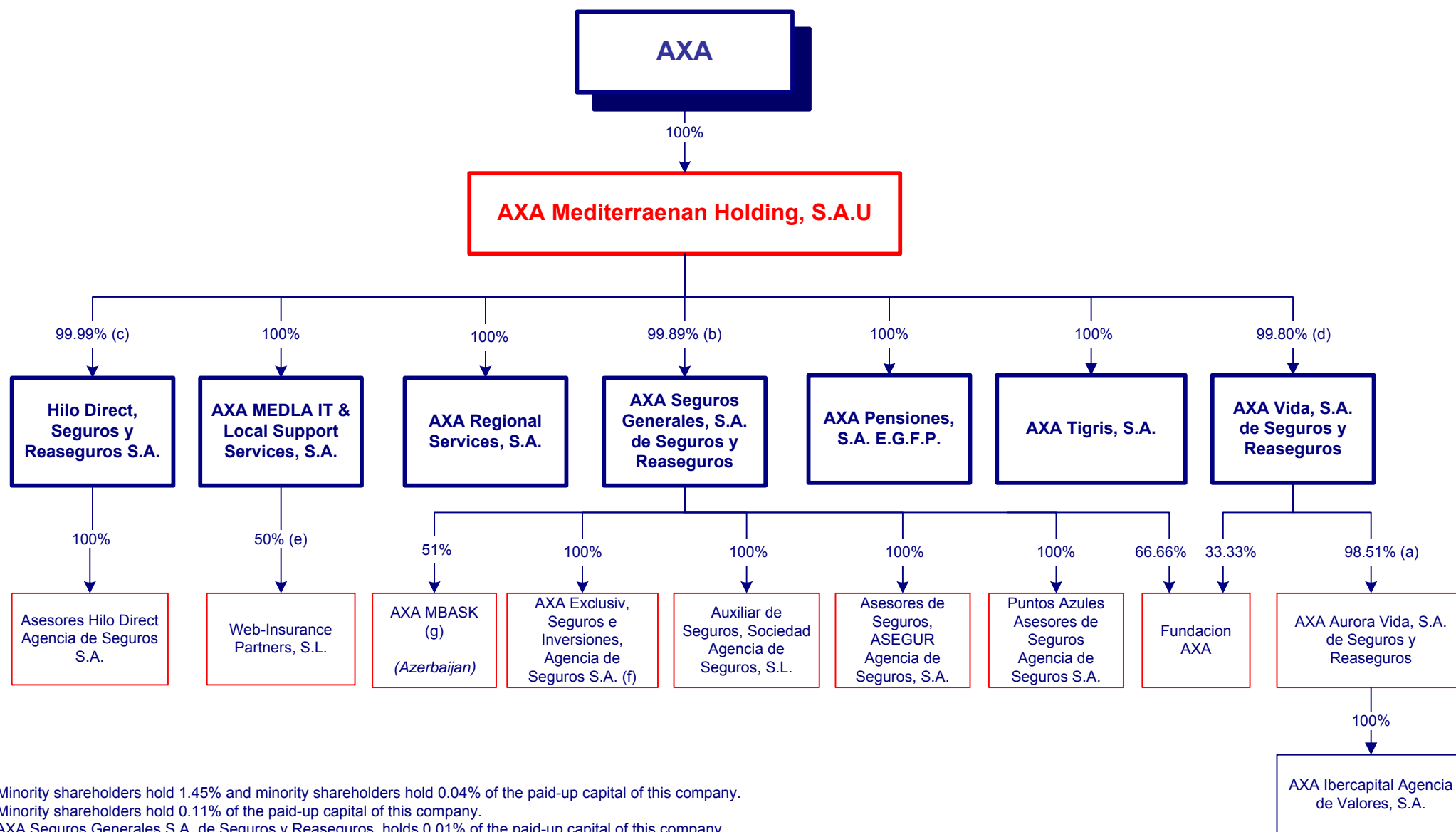

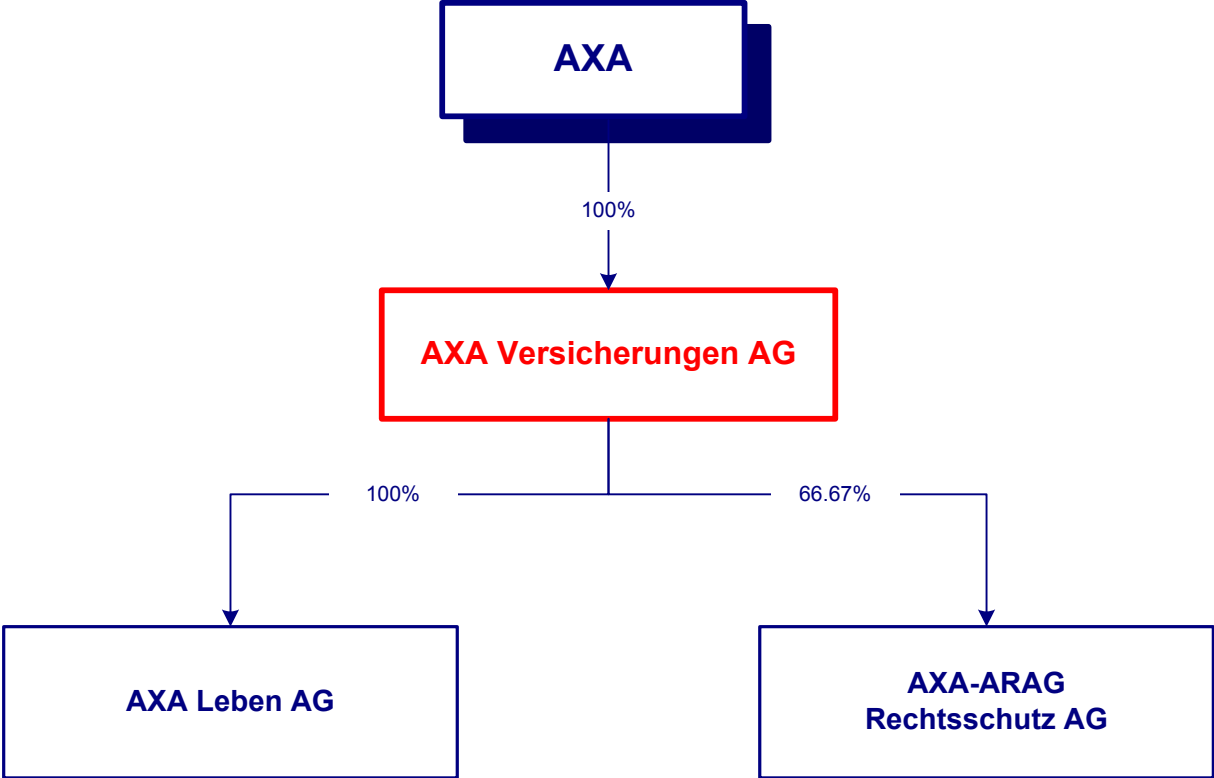

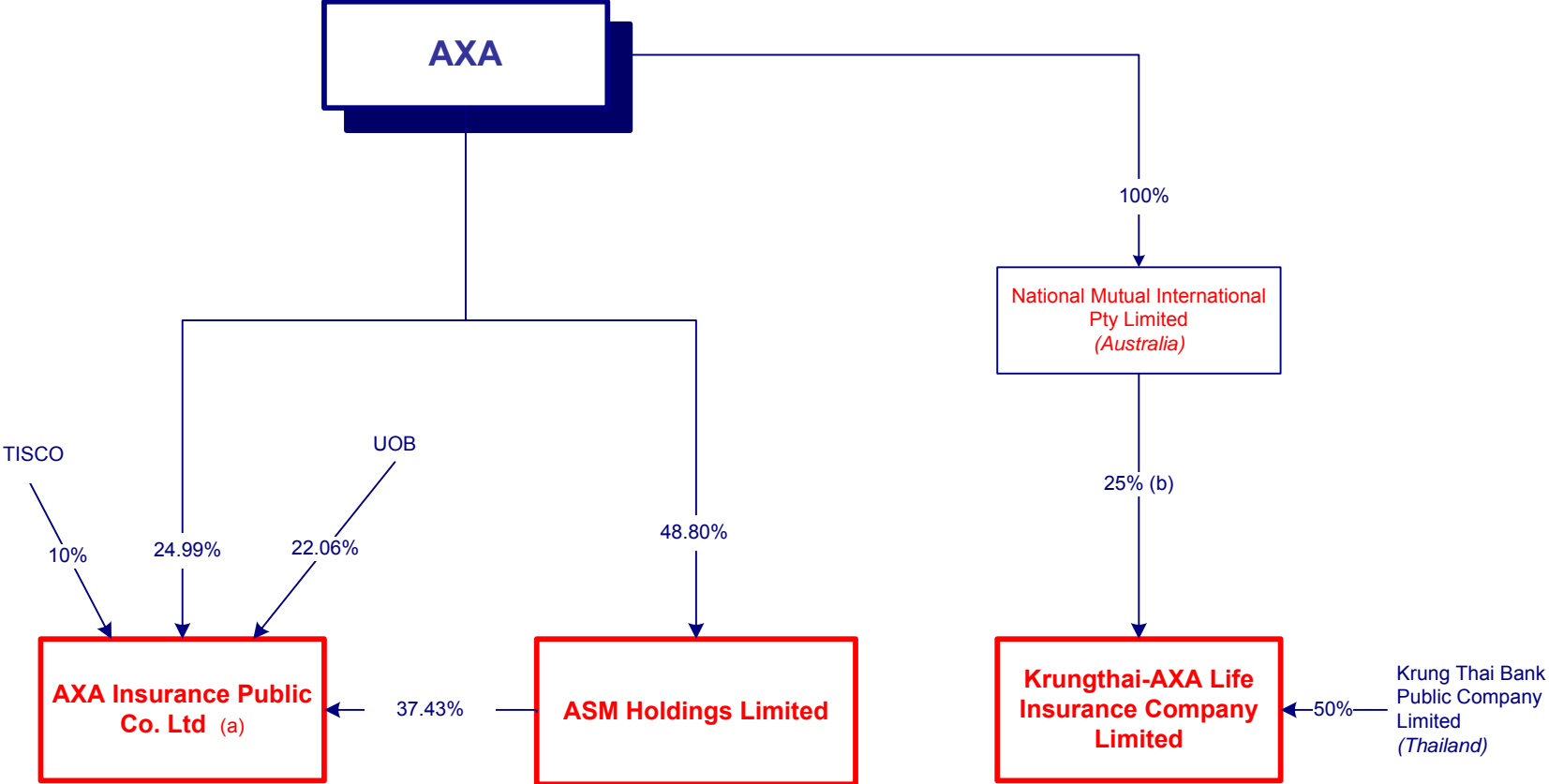

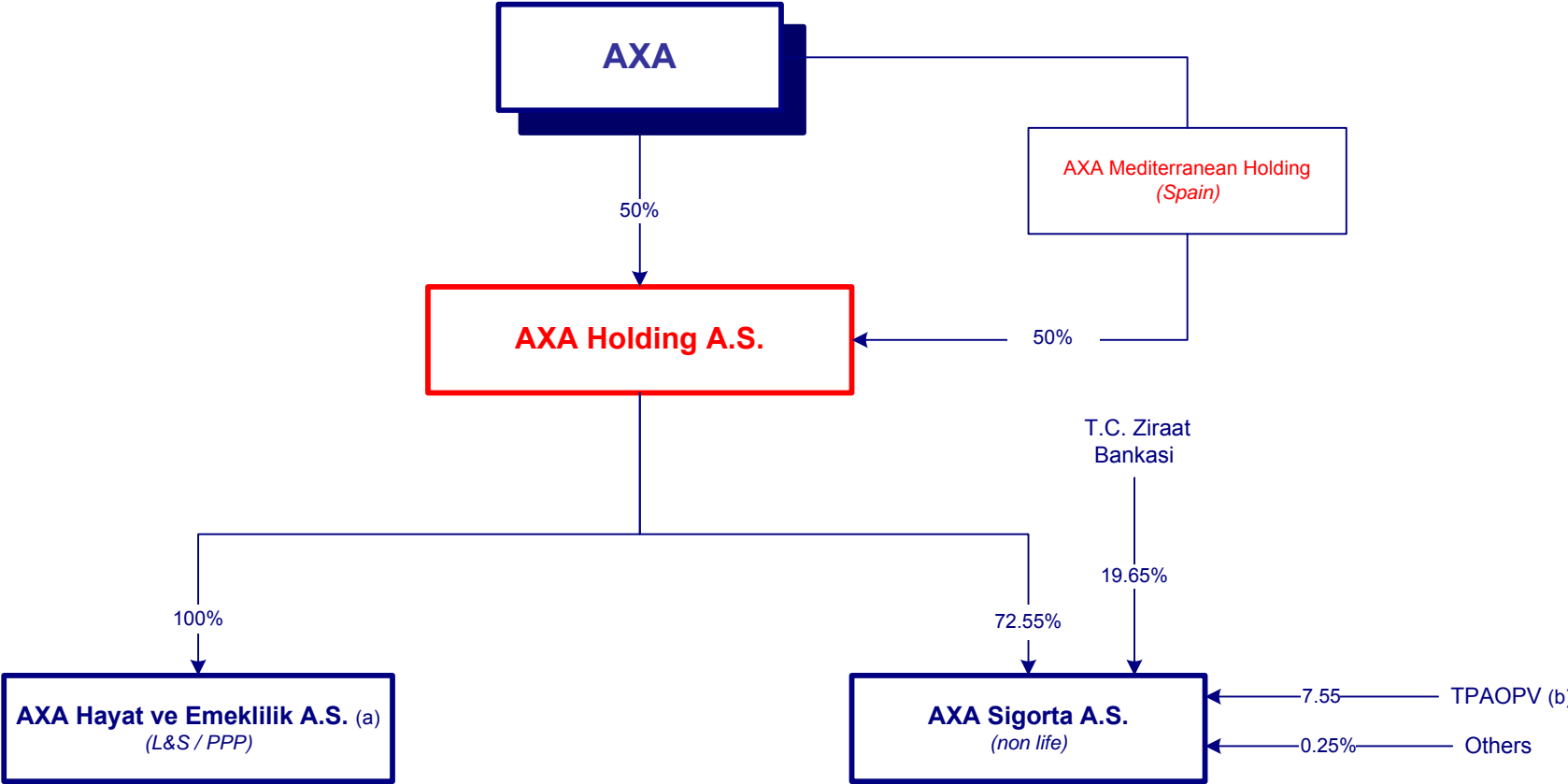

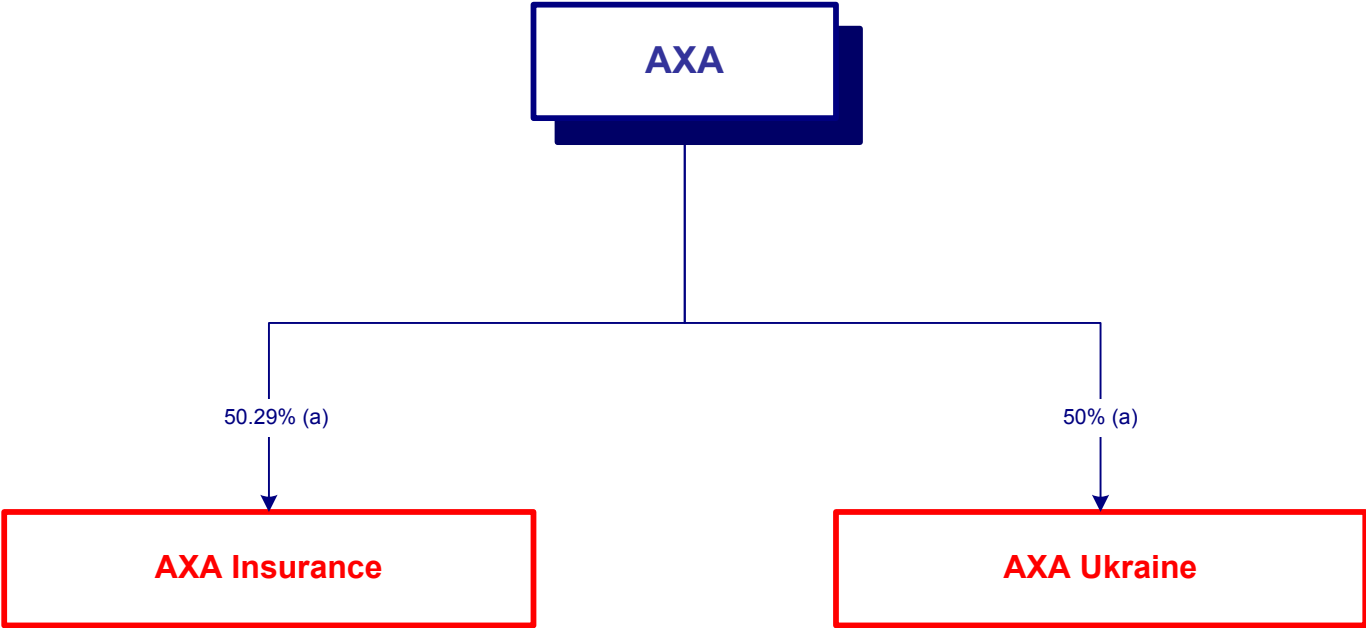

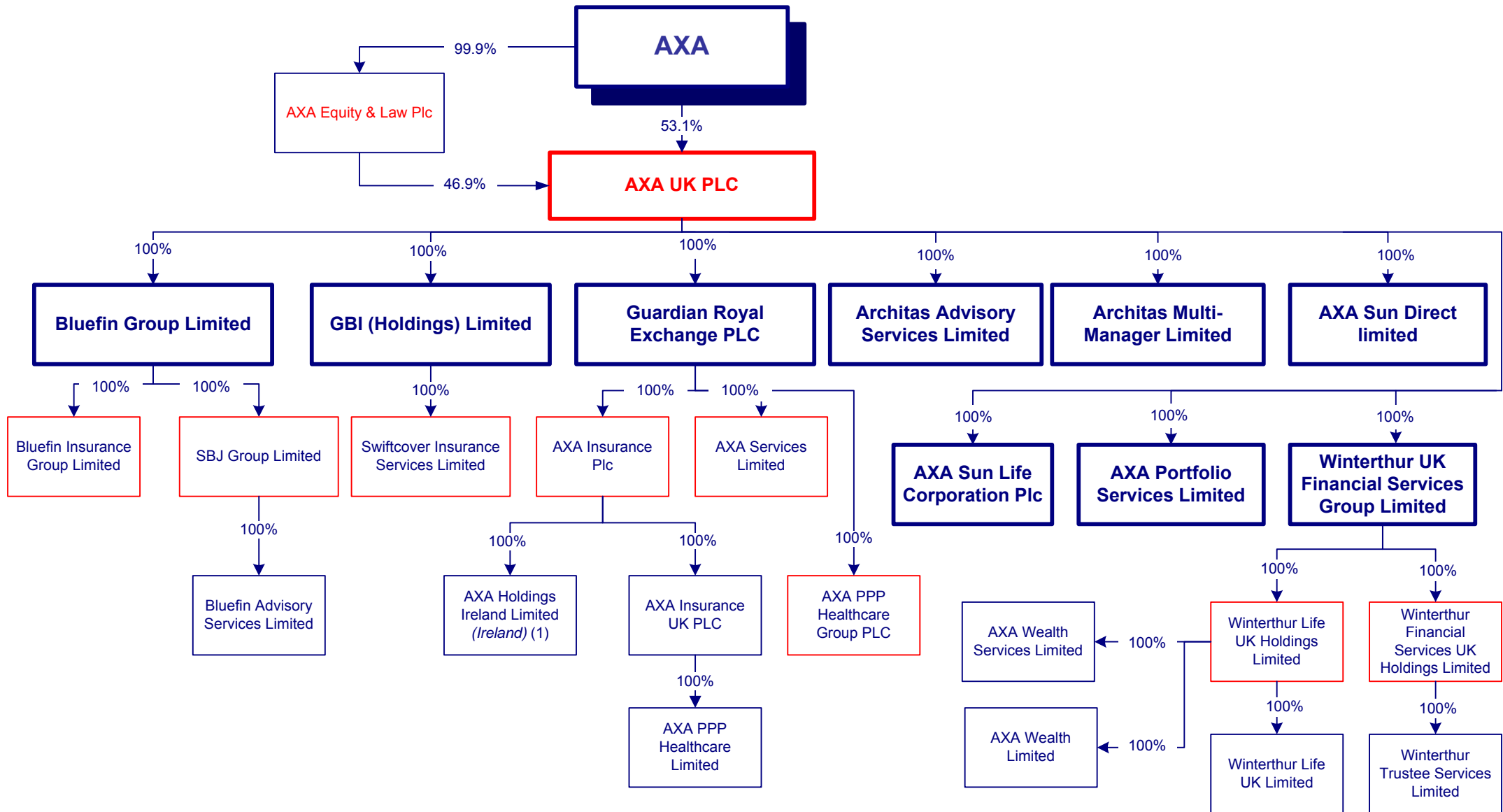
